Explanatory note

The object of this Regulation is to substitute the description of the foreshore area contained in Schedule 1 to the *Sydney Harbour Foreshore Authority Act 1998* (being land on or in the vicinity of the foreshores of Sydney Harbour in respect of which the Sydney Harbour Foreshore Authority exercises its functions under that Act).

This Regulation is made under the *Sydney Harbour Foreshore Authority Act 1998*, including sections 45 and 46 (the general regulation-making power).

Sydney Harbour Foreshore Authority Amendment (Foreshore Area) Regulation 2002

1 Name of Regulation

This Regulation is the Sydney Harbour Foreshore Authority Amendment (Foreshore Area) Regulation 2002.

2 Amendment of Sydney Harbour Foreshore Authority Act 1998 No 170

The *Sydney Harbour Foreshore Authority Act 1998* is amended by omitting the matter in Schedule 1 and by inserting instead the following:

The area bounded by a heavy black line drawn on the map marked "Sydney Harbour Foreshore Authority—Foreshore Area—Amendment No 3" catalogue number 05099916007, dated 15 February 2002, copies of which are deposited in the offices of the Authority and the Department of Planning.

1 Name of plan

This plan is *State Environmental Planning Policy No 56—Sydney Harbour Foreshores and Tributaries (Amendment No 6).*

2 Aims of Policy

This Policy aims to amend *State Environmental Planning Policy No 56—Sydney Harbour Foreshores and Tributaries* so as to include the land comprising the Caltex site at Ballast Point in Schedule 1 to that Policy, as a consequence of which certain development, if carried out on that land, will be State significant development.

3 Land to which Policy applies

This Policy applies to the land shown edged heavy black on the map sheet marked "Schedule 1—Map 18—Caltex Site, Ballast Point", a copy of which is deposited in the head office of the Department.

4 Amendment of State Environmental Planning Policy No 56—Sydney Harbour Foreshores and Tributaries
