**FISHERIES MANAGEMENT ACT 1994**Section 9 (2) Notification – Urgent Fishing Closure  
Ocean Waters Adjacent to the Bellinger River

I, Richard Sheldrake, prohibit the taking of fish (including prawns) by the methods of fishing as described in Column 1 of the Schedule to this notification, from the waters specified in Column 2 of that Schedule, for the period specified in the Conditions.

The otter trawl net	Ocean waters adjacent to the mouth of the Bellinger River, within a radius of 4 nautical miles of the eastern most point of the northern break wall at Mylestom.
Conditions: For a period of two months	

**FISHERIES MANAGEMENT ACT 1994**Section 8 Notification – Fishing Closure  
Byron Bay, County of Rous

I, Richard Sheldrake, prohibit the taking of fish by the methods of fishing as described in Column 1 of the Schedule to this notification, from the waters specified in Column 2 of that Schedule, at the times specified in the Conditions.

This prohibition is effective for a period of five (5) years from the date of publication of this notification, unless sooner varied or revoked by notification of the Deputy Director-General, Agriculture and Fisheries

## Byron Bay – Netting closure

Column 1 <i>Methods</i>	Column 2 <i>Waters</i>
By means of nets of every description, except the hand hauled prawn net, dip or scoop net, push or scissors net, hoop or lift net and the landing net, as prescribed by Regulation.	The whole of the waters of that part of Byron Bay, South Pacific Ocean, situated south-west of Cape Byron and known as Little Beach (or Watego Beach).
Conditions: During the period 1 April to 30 June in each year.	

Note: This closure applies to commercial fishers.

**FISHERIES MANAGEMENT ACT 1994**Section 8 Notification – Fishing Closure  
Whittakers Creek, County of Dampier

I, Richard Sheldrake, prohibit the taking of fish by the methods of fishing as described in Column 1 of the Schedule to this notification, from the waters specified in Column 2 of that Schedule, for the period specified.

This prohibition is effective for a period of five (5) years from the date of publication of this notification, unless sooner varied or revoked by notification of the Deputy Director-General.

The whole of the waters of Whittakers Creek, upstream from Brou Lake, from a line drawn across the Creek from a post marked FD on the northern boundary of land portion 149 to a post marked FD on the southern boundary of land portion 92.
Conditions: Nil	

Note: This closure applies to recreational and commercial fishers.
