STATE EMERGENCY AND RESCUE MANAGEMENT ACT 1989 - ORDER

I, ROBERT JOHN CARR, Premier, in pursuance of section 60D of the State Emergency and Rescue Management Act 1989, do by this my Order, declare that the provisions of Part 3A of that Act apply to all volunteer emergency service workers from the State Emergency Service, NSW Rural Fire Service and the Volunteer Rescue Association carrying out or supporting storm response operations following the Muswellbrook hail storm of the 24 October 2004 and the wind storms of 27 October 2004 affecting the Sydney Metropolitan, Illawarra and South Coast areas.

This Order is to remain in force until Monday 8 November 2004.

FISHERIES MANAGEMENT ACT 1994

Section 11 Amendment of Fishing Closure

Alexandra Canal

I, Richard Sheldrake, amend the notification, which prohibits the taking of fish in Botany Bay and tributaries, as published in the *New South Wales Government Gazette* Number 210 on 8 November 2002.

The notification is amended by renaming Schedule 4 as Schedule 4 (a) and inserting Schedule 4 (b), as below, immediately following Schedule 4 (a) in the existing notification.

Schedule 4 (b) prohibits the taking of fish by all methods of fishing as described in Column 1 of the Schedule to this notification, from the waters specified in Column 2 of that Schedule, for the period specified.

This prohibition is effective for a period of five (5) years from the date of publication of this notification, unless sooner varied or revoked by notification of the Deputy Director-General, Agriculture and Fisheries.

Note: The word 'Regulation', where appearing in this notification, refers to the Fisheries Management (General) Regulation 2002

By all methods.	The whole of the waters of the Alexandra Canal from its source to its junction with the Cooks river.
