ENERGY AND UTILITIES ADMINISTRATION (ENERGY CONTRIBUTIONS) ORDER 2005

I, FRANK ERNEST SARTOR, M.P., Minister for Energy and Utilities, with the concurrence of ANDREW JOHN REFSHAUGE, M.P., Treasurer, make the following Order under section 34P of the Energy and Utilities Administration Act 1987.

This Order takes effect on 30 May 2005.

Explanatory note

Section 34P of the Energy and Utilities Administration Act 1987 provides that the Minister may, by order published in the *Government Gazette*, require any one or more distribution network service providers to make an annual contribution for a specified financial year to the Energy Savings Fund. The purpose of this Order is to require defined distribution network service providers to make an annual contribution to the Energy Savings Fund for the financial year commencing 1 July 2005.

1. Name of Order

This Order is the Energy and Utilities Administration (Energy Contributions) Order 2005.

2. Commencement

This Order commences on 30 May 2005.

3. Interpretation

The Explanatory Note to this Order does not form part of the Order.

4. Definitions

distribution network service provider means a distribution network service provider listed in column 1 of Schedule 1.

5. Annual contribution

- (1) A distribution network service provider is required to make an annual contribution to the Energy Savings Fund for the financial year commencing 1 July 2005.
- (2) The amount of the annual contribution to be paid by a distribution network service provider is as set out in column 2 of Schedule 1.

6. Time for payment

The annual contribution is to be paid by quarterly instalments (each being equal to one-fourth of the annual contribution payable) on or before the first day of August 2005, November 2005, February 2006 and May 2006.

Explanatory note

Section 34J of the Energy and Utilities Administration Act 1987, provides that the Minister may, by order published in the *Government Gazette*, require any one or more State water agencies to make an annual contribution for a specified financial year to the Water Savings Fund. The purpose of this Order is to require defined State Water agencies to make an annual contribution to the Water Savings Fund for the financial year commencing 1 July 2005.

1. Name of Order

This Order is the Energy and Utilities Administration (Water Contributions) Order 2005.

2. Commencement

This Order commences on 30 May 2005.

3. Interpretation

The Explanatory Note to this Order does not form part of the Order.

4. Definitions

State water agency means a State water agency listed in column 1 of Schedule 1.

5. Annual contribution

- (1) A State water agency is required to make an annual contribution to the Water Savings Fund for the financial year commencing 1 July 2005.
- (2) The amount of the annual contribution to be paid by a State water agency is as set out in column 2 of Schedule 1.
- (3) The annual contribution is to be paid in instalments as set out in item 6 below.

6. Time for payment

- (1) The first instalment is to be in the sum of \$1,000,000.00 and is to be paid on or before the 15th day of August 2005.
- (2) The second instalment is to be in the sum of \$6,500,000.00 and is to be paid on or before the last day of September 2005.
- (3) The third instalment is to be in the sum of \$7,500,000.00 and is to be paid on or before the last day of December 2005.
- (4) The fourth instalment is to be in the sum of \$7,500,000.00 and is to be paid on or before the last day of March 2006.
- (5) The fifth instalment is to be in the sum of \$7,500,000.00 and is to be paid on or before the last day of June 2006.
