# SYDNEY WATER CATCHMENT MANAGEMENT ACT 1998

Notice under Section 22(8)

Execution of revised Bulk Water Supply Agreement between Sydney Catchment Authority and Sydney Water Corporation

THE Sydney Water Catchment Management Act 1998 requires the Sydney Catchment Authority (SCA) to enter into arrangements with Sydney Water Corporation (Sydney Water) for the supply of water by the SCA to Sydney Water.

In September 2005, a revised agreement was placed on public exhibition. After exhibition, the Independent Pricing and Regulatory Tribunal reported to the Minister for the Environment on the revised agreement and the Treasurer was consulted about the terms of the agreement. The Minister for the Environment approved the terms of the new arrangements.

Any defect in a Nomination or alteration or addition to a Statutory Declaration in Support of Candidature must be rectified by the candidate prior to the close of nominations. A candidate may only withdraw his/her nomination in writing so as to be received by the Returning Officer prior to the close of nominations.

Should more than the required number of nominations be received, a draw will be conducted to determine the order of candidates' names on the ballot paper at the State Electoral Office, at 2:00 p.m., Wednesday, 10 May 2006. Candidates or their representatives are invited to attend.

#### Voting

Should an election be necessary a postal ballot will be conducted to close at Noon, Thursday, 29 June 2006. The roll for this election will close at Noon,10 May 2006. # **PUBLIC LOTTERIES ACT 1996**

## RULES – LOTTO

I, the Honourable GRANT McBRIDE, M.P., Minister for Gaming and Racing being the Minister for the time being administering the Public Lotteries Act 1996 (hereinafter referred to as "the Act"), pursuant to section 23 of the Act, DO HEREBY APPROVE the amendments to the Rules for the conduct by New South Wales Lotteries Corporation, a Corporation constituted under section 5 of the New South Wales Lotteries Corporatisation Act 1996, of Games of Lotto and Games of Promotional Lotto as attached to this notice. These amended Rules take effect on and from 27 April 2006.

#### **PUBLIC LOTTERIES ACT 1996**

#### LOTTO RULES

IT is hereby notified that the Minister administering the Public Lotteries Act 1996, has approved of the following amendments to the Rules for the conduct of the Game of Lotto and Promotional Lotto. In accordance with section 23(3)(b) of the Act, these Rules take effect on and from 27 April 2006. These rules supersede the Rules notified previously in the *Government Gazette*.

## RULE 12

- In Rule 12(d), delete the words "rounded up to the nearest five (5) cents" and replace with the words "rounded to the nearest five (5) cents".
- Delete existing Rule 12(e) and replace with following new Rule:
  - (e) Monday and Wednesday Competitions

In respect of the Monday Competition and Wednesday Competition, the Prize Pool, not including the amount allocated for the payment of Double Up Prizes, shall be distributed as nearly as possible in the percentages shown below. The Prize Pool distribution shall be subject to a rounding process (which shall be to the nearest sum containing a five (5) cent multiple). Monies required for rounding up shall be drawn from the Division 1 Prize Pool. Where a rounding down process has occurred, the excess monies shall be paid into the Division 1 Prize Pool. . Where there is no winner in any one division, subject to the provisions of Division 1 (ii) of this paragraph (e) the percentage of the Prize Pool specified in that division shall be added to the percentage of the Prize Pool specified in the next lower division that contains a winning Entry or Entries or Syndicate Entry or Syndicate Entries in the order as shown below.

Division 1-

- (i) A Prize of an amount equal to 50% of the Prize Pool shall be payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains all six (6) of the Winning Numbers.
- (ii) If no Prize in this Division is payable in respect of any Entry or Syndicate Entry, an amount equal to 50% of the Prize Pool shall be retained in the Prize Fund so as to form part of the monies payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains all six (6) of the Winning Numbers in the Jackpot Competition.

#### Division 2-

A Prize of an amount equal to 3.7% shall be payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains five (5) but not more than five (5) of the six (6) Winning Numbers together with one (1) or both of the Supplementary Numbers.

## Division 3–

A Prize of an amount equal to 6.8% of the Prize Pool, or where there is no Prizewinner in Division 2, 10.5% of the Prize Pool, shall be payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains five (5) but no more than (5) of the six (6) Winning Numbers.

#### Division 4-

An amount equal to 17.0% of the Prize Pool shall be allocated to this Division, or

- (i) where there is no Prizewinner in Division 3, 23.8% of the Prize Pool; or
- (ii) where there are no Prizewinners in Divisions 2 and 3, 27.5% of the Prize Pool

shall be payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains four (4) but not more than four (4) of the six (6) Winning Numbers;

Division 5-

A Prize of an amount equal to 22.5% of the Prize Pool, or

- (i) where there is no Prizewinner in Division 4, 39.5% of the Prize Pool; or
- (ii) where there are no Prizewinners in Divisions 3 and 4, 46.3% of the Prize Pool; or

(iii) where there are no Prizewinners in Divisions 2, 3 and 4, 50% of the Prize Pool

shall be payable in respect of any Entry or Syndicate Entry which, or shall be shared equally between any two (2) or more Entries and/or Syndicate Entries each of which, contains three (3) but not more than three (3) of the six (6) Winning Numbers together with one (1) or both of the Supplementary Numbers.

- Delete existing Rule 12(g) and replace with following new Rule:
  - (g) Double Up

Where a Player has paid the additional Fee to enter into Double Up, and has won a Prize in accordance with Rule 12(e) Division 2, Division 3, Division 4 or Division 5, then the Player shall be entitled to receive an additional Prize equivalent to that Prize.

The Double Up arrangements do not apply to Rule 12 (e) Division 1.
