CASINO CONTROL ACT 1992

Order

PURSUANT to section 66 (1) of the Casino Control Act 1992, the Casino Control Authority does, by this Order, approve the following amendments to the rules for the playing of the game of "Roulette" in the casino operated by Star City Pty Limited under licence granted by the Casino Control Authority on 14 December 1994:

- (1) Amendments to the rules for the playing of "Roulette"
 - (a) Within Roulette sub-rule 1.1, the following new definition of "Triplestar" is approved: "Triplestar" means an optional additional wager, which may be made by a player in accordance with rule 3.5;
 - (b) Within Roulette sub-rule 1.1, the following new definition of "Triplestar button" is approved: "Triplestar button" means a button that is placed on the winning number to denote the number of repeat spins for a particular number;
 - (c) Roulette sub-rule 2.2 is repealed and in substitution therefor, the following new sub-rule 2.2 is approved:
 - 2.2 The layout cloth of the table shall display the name and/or logo of the casino, shall have areas designated for the placement of wagers and shall be marked in a manner substantially similar to that shown in diagram "A" or "B" or "C" or "D" or "E" or "F" or "G" or "H" or "I".
 - (d) Roulette sub-rule 2.3 is repealed and in substitution therefor, the following new sub-rule 2.3 is approved:
 - 2.3 The roulette wheel shall have:
 - 2.3.1 37 equal compartments with one marked zero and indicated by the colour green and the others marked 1 to 36 and indicated by the colours alternately red and black around the wheel; and

- 2.3.2 the numbers marked in the same order as that shown in diagram "J" or "K".
- 2.3.3 38 equal compartments with one marked zero and another marked double zero and indicated by the colour green and the others marked 1 to 36 and indicated by the colours alternately red and black around the wheel; and
- 2.3.4 the numbers marked in the same order as that shown in diagram "L".
- (e) Existing Roulette sub-rule 2.6.2 is renumbered as sub-rule 2.6.3 and the following rule is approved as new sub-rule 2.6.2:
 - 2.6.2 where layout "H" or "I" is in use a Triplestar button to denote the number of repeat spins for a particular number:
- (f) Roulette sub-rule 3.1 is repealed and in substitution therefor, the following new sub-rule 3.1 is approved:
 - 3.1 Diagrams "M", "N" and "O" are illustrations of the correct manner of placement of wagers on a roulette layout.
- (g) Existing Roulette sub-rules 3.5 to 3.16 are renumbered as sub-rules 3.6 to 3.17 and the following rule is approved as new sub-rule 3.5:
 - 3.5 Where the Triplestar option is offered, players may only place their wagers on the single star symbol on the layout. Where the same number is spun twice consecutively the dealer shall move the wager to the double star symbol where it will remain until the result of the third consecutive spin is determined. Wagers on the Triplestar option shall:
 - 3.5.1 win if the same number is spun two times consecutively, otherwise shall lose; and
 - 3.5.2 win if the same number is spun three times consecutively, otherwise shall lose.
- (h) Roulette sub-rule 3.17 is repealed and in substitution therefor, the following new sub-rule 3.17 is approved:
 - 3.17 A casino supervisor may modify the application of rule 3.16 if it is apparent, in the circumstances, that a strict application of the rule would be unfair to the player.
- (i) Roulette sub-rule 5.5.1 is repealed and in substitution therefor, the following new sub-rule 5.5.1 is approved:
 - 5.5.1 in the case where no race-track or Triplestar option is in use, collect all losing wagers from the layout then proceed to pay all winning wagers;
- (j) Roulette sub-rule 5.5.4 is repealed and in substitution therefor, the following new sub-rule 5.5.4 is approved:
 - 5.5.4 in the case where the Triplestar wager is offered:
 - 5.5.4.1 where the winning number is not the same number as the previous winning number:
 - 5.5.4.1.1 collect all Triplestar wagers on the layout;
 - 5.5.4.1.2 collect all other losing wagers on the layout and proceed to pay all winning wagers.
 - 5.5.4.2 where the winning number is the same number as the previous winning number:
 - 5.5.4.2.1 move any wagers on the double star symbol to the triple star symbol;
 - 5.5.4.2.2 move any wagers on the single star symbol to the double star symbol;
 - 5.5.4.2.3 collect all losing wagers on the layout;
 - 5.5.4.2.4 pay all winning wagers as defined in rule 3.2;
 - 5.5.4.2.5 pay all winning wagers on the triple star symbol and return the original wager to the player;
 - 5.5.4.2.6 pay all winning wagers on the double star symbol.
 - 5.5.4.3 where the winning number is the same number as the previous winning number the dealer shall place a Triplestar button on the number to indicate how many times the number has been spun consecutively, within the last three spins.
- (k) Roulette sub-rule 6.1 is repealed and in substitution therefor, the following new sub-rule 6.1 is approved:
 - 6.1 Winning wagers at the game of Roulette shall be paid at the odds listed below:

Wager	Odds
One number or Straight Up	35 to 1
Two numbers or Split	17 to 1
Three numbers or Street	11 to 1
Four numbers or Corner	8 to 1
5 numbers or Five-Line (only available with 00 option)	6 to 1
6 numbers or Six-Line	5 to 1
Column	2 to 1
Dozen	2 to 1
Low (1-18)	1 to 1
High (19-36)	1 to 1
Even	1 to 1
Odd	1 to 1

Red	1 to 1
Black	1 to 1
Triplestar – number spun two times consecutively	5 to 1
Triplestar – number spun three times consecutively	1000 to 1

- (1) Roulette sub-rule 9.9 is repealed and in substitution therefor, the following new sub-rule 9.9 is approved:
 - 9.9 Notwithstanding rule 5.5.4, a player who abstains from placing any wagers for three consecutive rounds of play, while all other seats or positions at the table are in use, may be required to vacate his/her seat or position.
- (m) Roulette sub-rule 10.2.2 is repealed and in substitution therefor, the following new sub-rule 10.2.2 is approved:
 - 10.2.2 Rule 3.12 is amended to the extent necessary for the following to have effect:
 - 10.2.2.1 where a player is issued with colour checks of more than one colour the colours so issued may be designated different values.
- (n) Existing Roulette diagrams "H" to "M" are renumbered as diagrams "J" to "O" and the following new Diagram "H" and Diagram "I" are approved:

DIAGRAM H ROULETTE LAYOUT – SINGLE ZERO WITH TRIPLESTAR





DIAGRAM I ROULETTE LAYOUT – DOUBLE ZERO WITH TRIPLESTAR
