1 Name of plan

This plan is Rockdale Local Environmental Plan 2000 (Amendment No 28).

2 Aims of plan

This plan aims:

- (a) to identify and conserve the environmental heritage of the City of Rockdale by adding additional properties to the schedule of heritage items to *Rockdale Local Environmental Plan 2000*, and
- (b) to ensure that any development of the land to which this plan applies does not adversely affect the heritage significance of those heritage items and their settings.

3 Land to which plan applies

This plan applies to the following land in the City of Rockdale:

- (a) 33 Dunmore Street North, Bexley (Lot B, DP 324948),
- (b) 7 Fairview Street, Arncliffe (Lot 20, DP 9096),

Explanatory note

The object of this Regulation is to amend the *Crimes (Administration of Sentences)* Regulation 2001 to prescribe additional circumstances in which a parole order that has not yet taken effect may be revoked under section 130 of the *Crimes (Administration of Sentences)* Act 1000

This Regulation is made under the *Crimes (Administration of Sentences) Act 1999*, including sections 130 and 271 (the general regulation-making power).

- (c) circumstances in which:
 - (i) a request is made under section 172 of the Act, or a direction is given by a court (whether or not under the Act), for the Parole Authority to consider whether the order should be revoked on a specified ground, and
 - (ii) the Parole Authority decides that the order should be revoked on that ground.
