Appointment of Inspector

*Vaccine* means ProteqFlu Suspension for Injection for Horses and ProteqFlu-Te Suspension for Injection for Horses.

#### PLANT DISEASES ACT 1924

Backyard Treatment to Control Queensland Fruit Fly

An Important Message to All Residents in the NSW Fruit Fly Exclusion Zone

TO control and eradicate Queensland fruit fly in the NSW Fruit Fly Exclusion Zone, Order OR95 has been issued under the Plant Diseases Act 1924 to allow NSW Department of Primary Industries (NSW DPI) inspectors to enter backyards in certain towns and carry out a treatment program. The control program will commence on 2 November 2007 and will be carried out by trained staff at no cost to householders.

The program may include:

- Bait spraying to the foliage of plants
- Cover spraying of fruit trees
- Release of sterile fruit flies

Objections may be lodged in writing by Thursday 1 November 2007, if you have concerns about your land being treated.

A written objection can be hand delivered to a NSW DPI district office or posted to the Regional Director DPI Relations South West, NSW Department of Primary Industries, Private Mail Bag, Yanco NSW 2703 by 4 pm on Thursday 1 November 2007.

Alternatively a written objection may be handed to an inspector who enters your land to carry out work. This can be done at anytime.
