Explanatory note

The object of this Regulation is to prescribe certain offences under the *Stock Foods Act 1940* and the *Stock Foods Regulation 2005* as penalty notice offences for the purposes of that Act and that Regulation.

This Regulation is made under the *Stock Foods Act 1940*, including sections 32A (Penalty notices) and 35 (the general regulation-making power).

Her Excellency the Governor, with the advice of the Executive Council, has made the following Regulation under the *Stock (Chemical Residues) Act 1975*.

Explanatory note

The object of this Regulation is to prescribe certain offences under the *Stock (Chemical Residues) Act 1975* and the *Stock (Chemical Residues) Regulation 2005 (the 2005 Regulation)* as penalty notice offences for the purposes of that Act and that Regulation.

This Regulation also increases from 20 penalty units (\$2,200) to 50 penalty units (\$5,500) the maximum penalty that may be imposed under the 2005 Regulation for offences relating to a permanent stock identifier.

This Regulation is made under the *Stock (Chemical Residues) Act 1975*, including sections 15A (Penalty notices) and 16 (the general regulation-making power).

Lower Lachlan Groundwater Order Number 4, 2007

I, PHILIP CHRISTIAN KOPERBERG MP, Minister for Climate Change, Environment and Water, in pursuance of section 45(4) of the Water Management Act 2000 and with the concurrence of the Minister for Primary Industries, do, by this my Order, amend the *Water Sharing Plan for the Lower Lachlan Groundwater Source 2003* by omitting from clause 3 the matter '1 June 2007' and by inserting instead the matter '1 July 2007'.

This Order takes effect on the date that it is published in the Gazette.
