EXOTIC DISEASES OF ANIMALS ACT 1991

Appointment of Inspectors

I, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, pursuant to section 67 of the Exotic Disease of Animal Act 1991 ('the Act''), appoint the persons included in the classes of persons described in the schedule below as Inspectors for the purpose of the exercise and performance of the powers and functions of an Inspector under the Act, from date of appointment until 1 October 2007.

Schedule

- 1. Persons appointed as Authorised Persons by the Centennial Park and Moore Part Trust (known as Centennial Parklands Rangelands);
- 2. Members of the Australian Veterinary Reserve; and
- 3. Fisheries Officers appointed under the Fisheries Management Act 1994.

ORDER - Section 15

Declaration of restricted area - Centennial Park

I, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 and pursuant to section 15 of that Act and being of the opinion that the area specified in Schedule 1 may be or become infected with the exotic disease Equine influenza hereby declare:

- 1. the area specified in Schedule 1 to be a restricted area, and
- 2. that the classes of animals, animal products, fodder, fittings or vehicles to which this order applies are those described in Schedule 2 which have originated from the restricted area.

SCHEDULE 1

The area shown in the map below and described as follows:

Commencing at the southern end of the Sydney Harbour Bridge at Dawes Point, thence along the southern coastline of Port Jackson in a generally westerly direction to Pyrmont Bridge, thence by Pyrmont Bridge to the Pyrmont Peninsula, thence in a generally counter-clockwise direction along the coastline around Pyrmont Peninsula to the Anzac Bridge, thence along Anzac Bridge to Rozelle, thence in a generally counter-clockwise direction along the coastline around the Balmain and Birchgrove Peninsula to Iron Cove Bridge, thence by Iron Cove Bridge to Drummoyne, thence in a generally counter-clockwise direction around the Drummoyne Peninsula to the Gladesville Bridge, and thence continuing by the coastline to Abbotsford Wharf, and thence to the northern end of the Great North Road, and thence southerly along the Great North Road to its junction with the Great Western Highway (Parramatta Road), thence westerly along the Great Western Highway to its junction with Croydon Road, and thence in a southerly direction along Croydon Road to its junction with Elizabeth Street, thence in a generally easterly direction along Elizabeth Street to its junction with Frederick Street, thence southerly along Frederick Street and southerly along its continuation as Milton Street, and thence southerly along its continuation as King Street to its junction with Jeffrey Street, thence southerly along Jeffrey Street to its junction with Canterbury Road, thence in a generally south-westerly direction along Canterbury Road to where it crosses Cooks River, then downstream along the northern edge of Cooks River to its mouth where it flows into Botany Bay, then continuing around the northern coastline of Botany Bay in a generally clockwise direction to Henry Head and Cape Banks, and continuing in a generally northerly direction along the coastline to the South Head of Port Jackson, and then southerly and westerly along the southern coastline of Port Jackson to the point of commencement.

ORDER - Section 20

Area Restriction Order - Eastern Creek

I, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 ("the Act"), direct the owners or persons in charge of any animals specified in Schedule A which are within the restricted area declared by me on 25 August 2007 entitled 'Declaration of Restricted Area – Eastern Creek', to take the measures specified in Schedule B for the purpose of preventing, controlling or eradicating the exotic disease Equine influenza.

Measure

Any animal specified in Schedule A must be:

- 1. kept confined by fence, enclosure or other method at the premises at which it is located as at 12.01am on the date of this Order;

Area Restriction Order - Centennial Park

ORDER - Section 21

Declaration of control area - State of New South Wales

- I, BRUCE MORGAN CHRISTIE, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 and pursuant to section 21 of that Act and being of the opinion that it is reasonably necessary for the purpose of preventing the spread of the exotic disease Equine influenza, do hereby declare:
- 1. the area specified in Schedule 1 to be a control area; and
- 2. that the classes of animals and animal products to which this order applies are those specified in Schedule 2 which have originated from the control area.

ORDER - Section 15

Declaration of restricted area - Eastern Creek

I, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 and pursuant to section 15 of that Act and being of the opinion that the area specified in Schedule 1 may be or become infected with the exotic disease Equine influenza hereby declare:


- 1. the area specified in Schedule 1 to be a restricted area, and
- 2. that the classes of animals, animal products, fodder, fittings or vehicles to which this order applies are those described in Schedule 2 which have originated from the restricted area.

SCHEDULE 1

The area shown in the map below and described as follows:

Commencing at the junction of the Cumberland Highway and the Great Western Highway, thence northerly along the Cumberland Highway to its junction with the Old Windsor Road, thence north-westerly along the Old Windsor Road to its junction with Schofields Road, thence westerly along Schofields Road to its junction with Railway Terrace, then northerly along Railway Terrace to its junction with Grange Avenue, then westerly along Grange Avenue to its junction with Richmond Road, then generally north-westerly along Richmond Road to its junction with St Marys Road, then south-westerly and southerly along St Marys Road, and southerly along its continuation, Stoney Creek Road, to the junction of Stoney Creek Road and Palmyra Avenue, thence westerly along Palmyra Avenue to its junction with South Creek Road, then northerly along South Creek Road to its junction with Eighth Avenue, then westerly along Eighth Avenue to its junction with Third Avenue, then south along Third Avenue to its junction with Ninth Avenue, then westerly along Ninth Avenue to its junction with The Northern Road, then southerly along The Northern Road (also known in parts as Richmond Road or Parker Street) to its junction with Elizabeth Drive, then generally easterly along Elizabeth Drive to its junction with Smithfield Road, then in a generally north-easterly direction along Smithfield Road to its junction with Polding Street, thence in a generally north-easterly and northerly direction along the Cumberland Highway (also known in parts as Smithfield Road, Warren Road, Betts Road or Jersey Road) to the point of commencement.
