
Declaration of Restricted Area – Local Government Areas of Auburn, Parramatta, Strathfield and northern part of Bankstown

- I, STEPHEN ELLIOTT DUNN, Deputy Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 ("the Act") and pursuant to section 15 of the Act and being of the opinion that the area specified in Schedule 1 may be or become infected with the exotic disease Equine influenza hereby declare:
- 1. the area specified in Schedule 1 to be a restricted area; and
- 2. that the classes of animals, animal products, fodder, fittings or vehicles to which this order applies are those described in Schedule 2.

SCHEDULE 1

The area shown in the following map and within the local government areas administered by Auburn Council, Parramatta City Council and Strathfield Municipal Council together with the northern part of the local government area administered by Bankstown City Council, the southern boundary of which commences at the point of intersection of Newbridge Road with the common boundary of the local government areas administered by Bankstown City Council and Liverpool City Council, thence in an easterly direction along Newbridge Road to its junction with Henry Lawson Drive and Milperra Road, thence in an easterly direction along Milperra Road to its junction with The River Road and Canterbury Road, thence in a generally easterly direction along Canterbury Road to its intersection with the common boundary of the local government areas administered by Bankstown City Council and Canterbury City Council.

EXOTIC DISEASES OF ANIMALS ACT 1991

NOTICE - Section 18

Entry and Exit Points to Restricted Areas

All public and private roads intersecting with the boundary of any restricted area, that has been declared or will be declared, pursuant to section 15 of the Exotic Diseases of Animals Act 1991 in relation to the exotic disease Equine influenza ('the restricted areas') are legal entry and exit points for horses, mules, donkeys and other animals in the Equidae family, the animal products, fodder and fittings of these animals, and vehicles transporting such animals, animal products, fodder and fittings.

The movement of all horses, mules, donkeys and other animals in the Equidae family, and their animal products, fodder and fittings, and vehicles transporting such animals, animal products, fodder and fittings into, within or out of the restricted areas is prohibited, unless

- · authorised by a permit issued by an inspector., and
- made through the entry and exit points specified in this notice.

If there is an inconsistency between this notice and any other notice made pursuant to section 18 of the Exotic Diseases of Animals Act 1991, the other notice prevails to the extent of the inconsistency.

Substantial penalties apply for breaches of these movement restrictions.

This notice is issued pursuant to section 18 of the Exotic Diseases of Animals Act 1991.



I, STEPHEN ELLIOTT DUNN, Deputy Chief Veterinary Officer, in accordance with the terms of my appointment pursuant to section 66(2) of the Exotic Diseases of Animals Act 1991 ("the Act"), and pursuant to section 68 of the Act, appoint the persons included in the classes of persons described in the Schedule below as Inspectors for the purpose of the exercise and performance of the powers and functions of an Inspector under the Act, from the date of this appointment until 1 November 2007.









ORDER - Section 22

Control Order - Events

- I, SIMON JOHN CHARLES OLIVER, an inspector under the Exotic Diseases of Animals Act 1991 ("the Act"), having been directed by, STEPHEN ELLIOTT DUNN, Deputy Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby declare:
- 1. pursuant to section 22(1)(a) of the Act, that the controls set out in the Schedule below apply to:
 - (a) horses, mules, donkeys and other animals in the Equidae family, and
 - (b) animal products of horses, mules, donkeys and other animals in the Equidae family, in the Control Area (including all Restricted Areas) from the date of this Control Order until 17 September 2007.
- 2. where there is an inconsistency between this Control Order and any previous Control Order in relation to the controls set out in the Schedule below, this Control Order prevails.

SCHEDULE

- (i) The holding of markets, fairs, sales, shows, parades, race meetings or other gatherings or competitions involving animals or animal products to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer.
- (ii) The presence or exposure of animals or animal products to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer, at any place where animals or animal products are exposed for sale.
- (iii) The presence or exposure of animals to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer, at any place where animals are exposed for exhibition, parades, race meetings or any form of recreation or competition.

Definitions:

In this Control Order:

Control Area means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

Restricted Area means any restricted area that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.
