Poisons and Therapeutic Goods Amendment (Fees) Regulation 2007

under the

Poisons and Therapeutic Goods Act 1966

His Excellency the Lieutenant-Governor, with the advice of the Executive Council, has made the following Regulation under the *Poisons and Therapeutic Goods Act* 1966.

Explanatory note

The object of this Regulation is to amend the *Poisons and Therapeutic Goods Regulation* 2002 to increase certain fees in relation to the supply of substances included in Schedule 2 to the Poisons List, the wholesale supply of poisons and restricted substances and the manufacture and supply of drugs of addiction.

The fee increases are generally in line with movements in the Consumer Price Index (adjusted to the nearest \$5).

This Regulation is made under the *Poisons and Therapeutic Goods Act 1966*, including sections 17 (1) (a1) and 24 (1) (f).

EXOTIC DISEASES OF ANIMALS ACT 1991

ORDER - Section 22

Control Order – Veterinary Practitioners

I, SALLY ANN SPENCE, an inspector under the Exotic Diseases of Animals Act 1991 ("the Act"), having been directed by, STEPHEN ELLIOTT DUNN, Deputy Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby order:

1. pursuant to section 22(1)(b) of the Act, that the measures set out in the Schedule below apply to:

- (a) horses, mules, donkeys and other animals in the Equidae family, and
- (b) animal products of horses, mules, donkeys and other animals in the Equidae family,

in the Control Area (including all Restricted Areas) from the date of this Control Order,

SCHEDULE

- 1. All veterinary practitioners and staff assisting a veterinary practitioner must, before coming into contact with any animal or animal product to which this Order applies, take the steps listed below:
 - a. completely cover your person with overalls that may be disposed of or laundered on site,
 - b. completely cover your hair with a hood or disposable hat,
 - c. put on a face mask,
 - d. put on rubber boots or disposable footwear that completely encloses your feet.
- 2. All veterinary practitioners and staff assisting a veterinary practitioner must, after coming into contact with any animal or animal product to which this Order applies, take the steps listed below, in the order they are listed, to decontaminate their person, vehicle and equipment:
 - a. After collecting any specimens, package them into a plastic bag to take back to car.
 - b. At car, blow nose into a tissue. Place tissue in plastic bag and leave on site for disposal.
 - c. Decontaminate your gloved hands with soap, detergent or disinfectant.
 - d. Wash the outside of the sample bag using soap, detergent or disinfectant and pack into a disposable esky with ice bricks.
 - e. Disinfect any equipment you have used, e.g. thermometer, vacutainer holder, by washing thoroughly with soap or detergent.
 - f. Scrub rubber boots using soap, detergent or disinfectant before placing in vehicle.
 - g. Remove overalls, gloves, mask and hair covering and leave on site for washing or disposal.
 - h. Wash hands, arms and any exposed skin and hair thoroughly with surgical scrub or soap. Continue washing for at least two minutes. Make sure any exposed skin that may have been contaminated with saliva, nasal secretions or mucus is cleaned thoroughly.
 - i. After returning home have a thorough shower for at least three minutes, including hair wash, and change into clean clothes.

Definitions:

In this Control Order:

Control Area means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

Restricted Area means any restricted area that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

ORDER - Section 15


Declaration of Restricted Area - Warrumbungle LGA

I, STEPHEN ELLIOTT DUNN, Deputy Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the Exotic Diseases of Animals Act 1991 ("the Act") and pursuant to section 15 of the Act:

- revoke the orders declared under section 15 of the Act entitled 'Declaration of Restricted Area – Baradine' dated 3 September 2007, 'Declaration of Restricted Area – 'Danu' Coonabarabran' dated 10 September 2007, and 'Declaration of Restricted Area – Bundella' dated 9 September 2007;
- 2. declare the area specified in Schedule 1 to be a restricted area; and
- 3. declare that the classes of animals, animal products, fodder, fittings or vehicles to which this order applies are those described in Schedule 2.

SCHEDULE 1

The area shown in the map below and within the local government area administered by the Warrumbungle Shire Council.



SCHEDULE 2

Class of animals

All horses.

Class of animal products

All animal products from horses.

Class of fodder and fittings

All fodder and fittings from, or used in connection with, horses.

Class of vehicles

All vehicles that, since 1 August 2007, have been used in connection with any of the classes of animals, animal products, fodder or fittings described in this Schedule.

In Schedule 2:

"*horses*" means horses, mules, donkeys and other animals in the Equidae family.
