# SPECIAL SUPPLEMEN

#### **FAIR TRADING ACT 1987**

#### INTERIM PROHIBITION ORDER

SECTION 30(1)

- I, LINDA BURNEY, Minister for Fair Trading,
- 1. noting that the supply of goods of the kind specified in Schedule 1 ("the Goods") has been prohibited on an interim basis under a law of the Commonwealth, in the interests of public safety, particulars of which are specified in Schedule 2; and
- 2. considering that the Goods are so dangerous that their supply should, in the interests of public safety, be prohibited immediately,

#### HEREBY:

- 3. prohibit, pursuant to section 30(1) of the Act, the supply of the Goods; and
- 4. declare that this Order shall expire three (3) months after the date of its publication in the New South Wales Government Gazette.

I, SALLY ANN SPENCE, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby revoke the Control Order entitled 'Control Order – Events' made by me on 16 September 2007 and any order revived as a result of this revocation **only insofar** as it applies to:

- 1. Events in the Protected Area (Green) that are authorised by the document dated 20 September 2007 and entitled 'Control Order Protected Area (Green) and
- 2. Events in a Special Restricted Area (Purple) that are authorised by the document dated 20 September 2007 and entitled 'General Permit to move specified animals, animal products, fodder, fittings and vehicles into, within and out of a Special Restricted Area (Purple) (section 24)'.

#### In this revocation:

**Event** means any market, fair, sale, parade, race meeting, recreational activity, competition or gathering.

**Protected Area (Green)** means that part of the Control Area known as the 'Protected Area (Green)' as specified in Schedule 1 to the Control Order dated 20 September 2007 entitled 'Control Order –Protected Area (Green)'.

Special Restricted Area (Purple) means any restricted area that is known as a Special Restricted Area (Purple) that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

This revocation commences on 21 September 2007.



# Declaration of Restricted Area – Special Restricted Area (Purple) – North Western Sydney

I, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, with the powers the Minister has delegated to me under section 67 of the *Exotic Diseases of Animals Act 1991* ('the Act') and pursuant to section 15 of the Act and being of the opinion that the area specified in Schedule 1 may be or become infected with the exotic disease Equine influenza hereby:

- declare the area specified in Schedule 1 to be a restricted area, to be known as "Special Restricted Area (Purple) – North Western Sydney" or as a "Special Restricted Area (Purple); and
- 2. that the classes of animals, animal products, fodder, fittings or vehicles to which this order applies are those described in Schedule 2.

#### **SCHEDULE 1**

## Special Restricted Area (Purple) - North Western Sydney

Those premises in the area shown in the map below and as described below:

The area within the line commencing at the point where the M7 motorway crosses Richmond Road, thence in a generally northerly and westerly direction along Richmond Road to its junction with Llandilo Road, thence south-westerly along Llandilo Road to the northern edge of Castlereagh Bicentennial Demonstration Forest, thence westerly along the northern edge of the Forest to The Northern Road, thence south-westerly along The Northern Road to its junction with Whitegates Road, thence westerly along Whitegates Road to its junction with Londonderry Road, thence southerly along Londonderry Road to its junction with Boscobel Road, thence westerly along Boscobel Road to its junction with Nutt Road, then northerly along Nutt Road to Devlin Road, then generally westerly along Devlin Road to the eastern bank of the Nepean River, thence across the Nepean River in a direct line to the mouth of Lynchs Creek, thence westerly and upstream along Lynchs Creek to where it flows out of the Blue Mountains National Park, thence generally northerly along the eastern boundary of the Blue Mountains National Park by the suburbs of Yarramundi, Grose Wold, Grose Vale, Bowen Mountain and Kurrajong Heights to a point at which the park boundary turns sharply west close to Rain Ridge Road, Kurrajong Heights, thence from this point directly north across the Bells Line of Road (about mid-way between Val Wheeler Drive and Coach House Road, Kurrajong Heights) to the boundary of the Wollemi National Park, thence generally easterly along the southern boundary of the Wollemi National Park (crossing Cedar Ridge Road and next the Comleroy Road) to where the Wollemi National Park meets the Putty Road at its junction with Packer Road, thence from this point easterly along the creek known as Turnbulls Arm to its confluence with the Colo River, thence downstream along the Colo River to its confluence with the Hawkesbury River, then generally easterly along the Hawkesbury River to One Tree Reach (just below Laughtondale), thence from the southern bank of the Hawkesbury River across the Singleton Road to the boundary of the Marramarra National Park close to One Tree Hill, thence along the northern and then western boundaries in an anticlockwise direction to the point at which the boundary approaches Canoelands Road about 1.5 km east of its junction with the Old Northern Road, thence directly south across Canoelands Road to a continuation of the boundary of the Marramarra National Park, then continuing in an anticlockwise direction in, first, a generally westerly and then a generally southerly and then a generally easterly direction along the boundary of the Marramarra National Park to where it meets Berowra Creek, thence directly across Berowra Creek to Muogamarra Nature Reserve, thence southerly and anticlockwise around the southern boundary of Muogamarra Nature Reserve to where it meets the Pacific Highway (close to the Cowan Works Depot), thence generally southerly along the Pacific Highway to its junction with Berowra Waters Road, thence in a generally north-westerly direction along Berowra Waters Road to where it meets the boundary of the Berowra Valley Regional Park, thence anticlockwise around the boundary of the Berowra Valley Regional Park (including its northern crossing of Berowra Creek at The Woolwash, and where it crosses the Galston Road in Galston Gorge) to where Georges Creek enters the Regional Park (close to Fallon Drive, The Knoll, Dural), thence generally westerly and upstream along Georges Creek to Hastings Road, thence southwesterly along the Hastings Road to its junction with Old Northern Road, thence southerly along the Old Northern Road to its junction with the Showground Road, thence generally westerly along the Showground Road to its junction with Norwest Boulevard, thence generally westerly along the Norwest Boulevarde to the M7 motorway, thence westerly along the M7 motorway to the point of commencement.



# EXOTIC DISEASES OF ANIMALS ACT 1991 EQUINE INFLUENZA ORDER - Section 22 Control Order - Control Area (Amber)

I, SALLY ANN SPENCE, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by BRUCE MORGAN CHRISTIE, Chief Veterinary Officer ("CVO"), pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby declare that:

- 1. that part of the Control Area other than all Protected Areas (Green) and all Restricted Areas is to be known as the "Control Area (Amber)";
- 2. the movement of horses into, out of or within the Control Area (Amber) is regulated as specified in Schedule 1;
- 3. the movement of animal products from horses into, out of or within the Control Area (Amber) is regulated as specified in Schedule 2;

# SCHEDULE 1 Authorised Movement of Horses

Movement of horses <u>into</u>, <u>out of</u>, <u>or within</u> the Control Area (Amber) is authorised **only if** that movement is in accordance with an authorisation issued by an inspector under the Act or a permit issued pursuant to section 24 of the Act.

#### **SCHEDULE 2**

#### **Authorised Movement of Animal Product from Horses**

Movement of animal products from horses <u>into</u>, <u>out of or within</u> the Control Area (Amber) is authorised **only if:** 

- 1. that movement is in accordance with an authorisation issued by an inspector under the Act or a permit issued pursuant to section 24 of the Act, or
- 2. the animal product being moved is specified below and moved in accordance with the conditions specified below:

Animal products from horses that are:

- (a) chilled or frozen semen or embryos from horses,
- (b) blood, urine or other diagnostic samples from horses that are:
  - (i) taken directly to a diagnostic laboratory, and
  - (ii) either held or disposed of in a manner approved under Australian Standards for the secure disposal of biological waste,
- (c) carcasses, meat or by-products from horses that are:
  - (i) from horses have been slaughtered at a premises that is licensed as a knackery under the *Food Act 2003 (NSW)*, and
  - (ii) from horses that have not originated from a premises or place that is declared an infected place under section 10 of the Act or which is subject to a quarantine order under section 35 of the Act, and
  - (iii) are cooked or rendered before those carcasses, meat or by-products from horses are fed to other animals.

#### **Interpretation:**

In this Control Order, if

- 1. any part of any premises is located partly within the Protected Area (Green) and partly within the Control Area (Amber) the whole of those premises is taken to be located in the Control Area (Amber).
- 2. any part of any premises is located partly within the Control Area (Amber) and partly within the Restricted Area (Red) the whole of those premises is taken to be located in the Restricted Area (Red).

#### **Definitions:**

In this Control Order:

*Control Area* means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

horses means horses, mules, donkeys and other animals in the Equidae family.

Part of Upper Lachlan Shire Council means that part of the Upper Lachlan Shire east of the line commencing at the point at which Woodhouselee Road (the road from Woodhouselee to Goulburn) crosses the common boundary of the Upper Lachlan Shire and the Goulburn Mulwaree Shire, thence along this road via Woodhouselee and then Roslyn to Laggan, thence from Laggan in a generally northerly direction via Peelwood to Tuena, then north from Tuena along the Junction Point Road to where it crosses the common boundary of the land administered by the Upper Lachlan Shire and the land administered by the Bathurst Regional Council. This description is to be interpreted in conjunction with the map sheet "GOULBURN SI55-12, NSW SOUTH WALES, EDITION 3", dated 2003, published by GEOSCIENCE Australia, Symonston ACT 2609.

**Premises** includes a parcel of land, or several parcels of land which:

- (i) are contiguous with one another or are separated from one another only by a road, river, creek or other watercourse, and
- (ii) constitute or are worked as a single property irrespective of whether those parcels are held under the same title or different titles or titles of different kinds.

**Protected Area (Green)** means that part of the Control Area known as the "Protected Area (Green)" which has been declared or may be declared pursuant to section 22 of the Act, in relation to the exotic disease Equine influenza.

**Restricted Area (Red)** means a restricted area which has been declared or may be declared pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza and known as a Restricted Area (Red).

*Unincorporated area* means such part of the land within the State that is not within a local government area.

#### **Control Order – Protected Area (Green)**

I, SALLY ANN SPENCE, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by BRUCE MORGAN CHRISTIE, Chief Veterinary Officer ("CVO"), pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby declare that:

- 1. this Control Order applies to that part of the Control Area specified in Schedule 1, to be known as the "**Protected Area** (**Green**)";
- 2. the movement of horses into, out of or within the Protected Area (Green) is regulated as specified in Schedule 2;
- 3. the movement of animal products from horses into, out of or within the Protected Area (Green) is regulated as specified in Schedule 3;
- 4. the holding of events within the Protected Area (Green) is regulated as specified in Schedule 4.



#### **SCHEDULE 2**

# **Authorised Movement of Horses**

- 1. Movement of horses <u>within</u> the Protected Area (Green) is authorised **only if** a Travelling Horse Statement is duly completed and any movement is in accordance with the conditions listed on the Travelling Horse Statement.
- 2. Movement of horses <u>into or out of</u> the Protected Area (Green) is authorised **only if** that movement is in accordance with an authorisation issued by an inspector under the Act or a permit issued pursuant to section 24 of the Act.

#### **SCHEDULE 3**

# **Authorised Movement of Animal Product from Horses**

- 1. Movement of animal products from horses within the Protected Area (Green) is authorised.
- 2. Movement of animal products from horses, <u>into or out of</u> the Protected Area (Green) is authorised **only if**:
  - a. that movement is in accordance with an authorisation issued by an inspector under the Act or a permit issued pursuant to section 24 of the Act; or

b. the animal product being moved is specified below and moved in accordance with the conditions specified below:

All animal products from horses that are:

- (a) chilled or frozen semen or embryos from horses,
- (b) blood, urine or other diagnostic samples from horses that are:
  - (i) taken directly to a diagnostic laboratory, and
  - (ii) either held or disposed of in a manner approved under Australian Standards for the secure disposal of biological waste,
- (c) carcasses, meat or by-products from horses that are:
  - (i) from horses have been slaughtered at a premises that is licensed as a knackery under the *Food Act 2003 (NSW)*, and
  - (ii) from horses that have not originated from a premises or place that is declared an infected place under section 10 of the Act or which is subject to a quarantine order under section 35 of the Act, and
  - (iii) are cooked or rendered before those carcasses, meat or by-products from horses are fed to other animals.

## **SCHEDULE 4**

#### **Authorised Events**

The holding of an Event is authorised **only if:** 

- 1. The proposed Event is registered with the Department of Primary Industries at least 48 hours prior to the Event taking place, by completing an Event Registration Form available at www.dpi.nsw.gov.au/equine-influenza/permits.
- 2. The Travelling Horse Statement identification number for all horses attending the Event is given to the Event organiser(s) on arrival at the Event location.
- 3. The Travelling Horse Statement identification number for all horses attending the Event is forwarded to the Department of Primary Industries by the Event organiser(s) within 24 hours of the Event taking place by completing the Event Attendance Form available at www.dpi.nsw.gov.au/equine-influenza/permits.
- 4. None of the horses at an Event originate from within a 10km radius of any premises or place quarantined pursuant to section 35 of the Act in relation to the exotic disease Equine influenza.

#### Interpretation

In this Control Order, if any part of any premises is located partly within the Protected Area (Green) and partly within the Control Area (Amber) the whole of those premises is taken to be located in the Control Area (Amber).

#### **Definitions**

In this Control Order:

**Control Area** means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

*Control Area* (*Amber*) means that part of the Control Area other than all Protected Areas (Green) and all restricted areas and known as the Control Area (Amber).

**Event** means any market, fair, sale, parade, race meeting, recreational activity, competition or other gathering of 10 or more horses, or any number of horses from 3 or more properties and where the horses are moved to the event and back to their premises of origin within 5 days.

*Horses* means horses, mules, donkeys and other animals in the Equidae family.

Part of Upper Lachlan Shire Council means that part of the Upper Lachlan Shire west of the line commencing at the point at which Woodhouselee Road (the road from Woodhouselee to Goulburn) crosses the common boundary of the Upper Lachlan Shire and the Goulburn Mulwaree Shire, thence along this road via Woodhouselee and then Roslyn to Laggan, thence from Laggan in a generally northerly direction via Peelwood to Tuena, then north from Tuena along the Junction Point Road to where it crosses the common boundary of the land administered by the Upper Lachlan Shire and the land administered by the Bathurst Regional Council. This description is to be interpreted in conjunction with the map sheet "GOULBURN SI55-12, NSW SOUTH WALES, EDITION 3", dated 2003, published by GEOSCIENCE Australia, Symonston ACT 2609.

**Premises** includes a parcel of land, or several parcels of land which:

- (i) are contiguous with one another or are separated from one another only by a road, river, creek or other watercourse, and
- (ii) constitute or are worked as a single property

irrespective of whether those parcels are held under the same title or different titles or titles of different kinds.

**Protected Area (Green)** means that part of the Control Area known as the Protected Area (Green) which has been or may be declared pursuant to section 22 of the Act, in relation to the exotic disease Equine influenza.

**Restricted Area** means any restricted area which has been declared or may be declared pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

*Travelling Horse Statement* means the document entitled "Exotic Diseases of Animals Act 1991 - Travelling Horse Statement" available from the Department of Primary Industries and at www.dpi.nsw.gov.au/equine-influenza/permits.

*Travelling Horse Statement identification number* means the unique number situated on the top right corner of a Travelling Horse Statement.

*Unincorporated area* means such part of the land within the Western Division of the State as is not within a local government area.

**Western Division** means the Western Division as defined by the *Crown Lands Consolidation Act* 1913 immediately before its repeal (subject to any regulations made under section 4 (3) of the <u>Crown Lands Act 1989</u> that affect the boundary between the Western Division and the Eastern and Central Division).

I, SALLY ANN SPENCE, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, pursuant to section 22(1)(b) of the Act:

- 1. revoke the Control Order made by me dated 11 September 2007 entitled 'Control Order Veterinary Practitioners' and the Control Order made by me dated 18 September 2007 entitled 'Control Order Requirements for Disinfection';
- 2. revoke the authorisation made by Simon Oliver, an inspector under the Act dated 31 August 2007 entitled 'Authorisation to move specified animal products into or within a control area';
- 3. declare that this order applies to:
  - (a) horses, mules, donkeys and other animals in the Equidae family, and
  - (b) animal products of horses, mules, donkeys and other animals in the Equidae family in a Special Restricted Area (Purple), other than those animal products permitted by Schedule 2 of the permit entitled "General Permit to move specified animals, animal products, fodder, fittings and vehicles into and out of a Special Restricted Area (Purple)" dated 20 September 2007; and
- 4. order all persons who come into contact with animals or animal products to which this Order applies, including veterinary practitioners, farriers, horse dentists, chiropractors and other assisting staff, must comply with the Schedule below.

#### **SCHEDULE**

1. After coming into contact with any animal or animal product to which this Order applies and before leaving a Special Restricted Area (Purple), must disinfect their person, and all vehicles, fittings (including equipment) and any other thing in their control or possession that has come into contact with any animal or animal product to which this Order applies.

#### **Definitions:**

In this Control Order:

*Control Area* means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

disinfect means bathe with a disinfectant chemical or heat, irradiate, fumigate or otherwise treat so as to destroy all Equine influenza virus present.

fittings means any stall, box, cage, enclosure, pen or material used for penning, yarding or the containing of any animal, and includes any equipment, harness, saddlery, rope, bucket, trough, bedding, utensil and implement used in the handling, keeping, treatment, care of or storage of animals, animal products or fodder.

Special Restricted Area (Purple) means any restricted area that is known as a Special Restricted Area (Purple) that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

This Control Order commences on 21 September 2007.

#### Control Order – Requirements for Disinfection for persons – Restricted Area (Red)

I, SALLY ANN SPENCE, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, pursuant to section 22(1)(b) of the Act:

- 1. declare that this order applies to:
  - (a) horses, mules, donkeys and other animals in the Equidae family, and
  - (b) animal products of horses, mules, donkeys and other animals in the Equidae family in a Restricted Area (Red), other than those animal products permitted by Schedule 2 of the permit entitled "General Permit to move specified animals, animal products, fodder, fittings and vehicles out of, into or within a Restricted Area (Red)" dated 20 September 2007;and
- 2. order all persons who come into contact with animals or animal products to which this Order applies, including veterinary practitioners farriers, horse dentists, chiropractors and other staff assisting, must comply with the Schedule below.

#### **SCHEDULE**

- 1. On entering a premises and before coming into contact with any animal or animal product to which this Order applies, take the steps listed below: must disinfect their person, and all vehicles, fittings (including equipment) and any other thing in their control or possession that has come into contact with any animal or animal product to which this Order applies; and
- 2. After coming into contact with any animal or animal product to which this Order applies and before leaving a premises within Restricted Area (Red), must disinfect their person, and all vehicles, fittings (including equipment) and any other thing in their control or possession that has come into contact with any animal or animal product to which this Order applies.

#### **Definitions:**

In this Control Order:

Control Area means the control area declared, pursuant to section 21 of the Act, by the Order made by the Chief Veterinary Officer, as the Minister's delegate under section 67 of the Act, on 25 August 2007.

disinfect means bathe with a disinfectant chemical or heat, irradiate, fumigate or otherwise treat so as to destroy all Equine influenza virus present.

fittings means any stall, box, cage, enclosure, pen or material used for penning, yarding or the containing of any animal, and includes any equipment, harness, saddlery, rope, bucket, trough, bedding, utensil and implement used in the handling, keeping, treatment, care of or storage of animals, animal products or fodder.

*Premises* includes a parcel of land, or several parcels of land which:

- (i) are contiguous with one another or are separated from one another only by a road, river, creek or other watercourse, and
- (ii) constitute or are worked as a single property

irrespective of whether those parcels are held under the same title or different titles or titles of different kinds.

Restricted Area (Red) means any restricted area that is known as a Restricted Area (Red) that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

This Control Order commences on 21 September 2007.

# General Permit to move specified animal products, fodder, fittings and vehicles out of, into or within a Restricted Area (Red) (section 24)

To any person in NSW

I revoke the document entitled "Permit to move specified animal products, fodder, fittings and vehicles out of, into or within a restricted area" dated 2 September 2007, and any permit revived as a result of this revocation.

I permit, pursuant to section 24 of the Exotic Diseases of Animals Act 1991 ("the Act"):

- 1. the animal products derived from horses, mules, donkeys and other animals in the equidae family ("horses"), specified in Schedule 1 and subject to the conditions specified in Schedule 1, to be moved out of, into or within any Restricted Area (Red) that is declared pursuant to section 15 of the Act.
- 2. fodder and fittings from or used in connection with horses, specified in Schedule 2 and subject to the conditions specified in Schedule 2, to be moved out of, into or within any Restricted Area (Red).
- 3. vehicles for or used in connection with horses since 1 August 2007, specified in Schedule 3 and subject to the conditions specified in Schedule 3, to be moved out of, into or within any Restricted Area (Red).

#### Schedule 1

All animal products from horses that are:

- (a) chilled or frozen semen or embryos from horses,
- (b) blood, urine or other diagnostic samples from horses that are:
  - (i) taken directly to a diagnostic laboratory, and
  - (ii) either held or disposed of in a manner approved under Australian Standards for the secure disposal of biological waste,
- (c) carcasses, meat or by-products from horses that are:
  - (i) from horses have been slaughtered at a premises that is licensed as an abattoir under the *Food Act 2003* (NSW), and
  - (ii) from horses that have not originated from a premises or place that is declared an infected place under section 10 of the Act or which is subject to a quarantine order under section 35 of the Act, and
  - (iii) are cooked or rendered before those carcasses, meat or by-products from horses are fed to other animals.

#### Schedule 2

- (a) All fodder that has not been in contact with or used in connection with any horses or any animal products from horses but excluding the animal products specified in Schedule 1.
- (b) All fittings that have been cleaned and disinfected to remove any animal products of horses.

#### Schedule 3

All vehicles that have been cleaned and disinfected to remove any animal products of horses.

#### **Definitions**

In this Permit:

**Restricted Area** (Red) means any restricted area that is known as a Restricted Area (Red) that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

disinfected means bathed with a disinfectant chemical or heated, irradiated, fumigated or otherwise treated so as to defeat infection.

#### **Equine influenza**

General Permit to move specified animals, animal products, fodder, fittings and vehicles into, within and out of a Special Restricted Area (Purple) (section 24)

To any person in NSW

I permit, pursuant to section 24 of the Exotic Diseases of Animals Act 1991 ("the Act"):

- a. horses, mules, donkeys, and other animals in the Equidae family ('horses') to be moved <u>into</u> or <u>within</u> a Special Restricted Area (Purple) subject of the conditions specified in Schedule 1;
- b. animal products from horses as specified in Schedule 2 to be moved <u>into</u>, <u>within or out of</u> a Special Restricted Area (Purple) subject to the conditions specified in Schedule 2;
- c. fodder and fittings from or used in connection with horses, to be moved <u>into</u>, <u>within or out of</u> a Special Restricted Area (Purple) subject to the conditions specified in Schedule 3; and
- d. vehicles for or used in connection with horses, be moved <u>into</u>, <u>within or out of</u> a Special Restricted Area (Purple) subject to the conditions specified in Schedule 4.

#### Schedule 1 – Permitted Movements of Horses

- 1. Movement of horses within a Special Restricted Area (Purple) is permitted.
- Movement of horses <u>into</u> a Special Restricted Area (Purple) is permitted only if that movement occurs on or before 19 October 2007 and is in accordance with an authorisation issued by an inspector under the Act or an additional permit issued pursuant to section 24 of the Act.

NOTE: This permit does not allow any movement of horses OUT of a Special Restricted Area (Purple).

#### Schedule 2 – Permitted Movements of Animal Products

- 1. Movement of animal products from horses is permitted within a Special Restricted Area (Purple).
- 2. Movement of animal products from horses is permitted into a Special Restricted Area (Purple).
- 3. Movement of the animal products specified below is permitted <u>out of</u> a Special Restricted Area (Purple) **only** if moved in accordance with the conditions specified below:

All animal products from horses that are:

- (a) chilled or frozen semen or embryos from horses,
- (b) blood, urine or other diagnostic samples from horses that are:
  - (i) taken directly to a diagnostic laboratory, and
  - (ii) either held or disposed of in a manner approved under Australian Standards for the secure disposal of biological waste.

# Schedule 3 - Permitted Movements of Fodder and Fittings

- 1. Movement of fodder and fittings from or used in connection with horses is permitted <u>within</u> a Special Restricted Area (Purple).
- 2. Movement of fodder and fittings from or used in connection with horses is permitted <u>into</u> a Special Restricted Area (Purple).
- 3. Movement of fodder <u>out of</u> a Special Restricted Area (Purple) is permitted **only if** that fodder has not been in contact with or used in connection with any horses or any animal products from horses or if the fodder has been in contact only with an animal product specified in paragraph 3 of the Schedule 2 above.
- 4. Movement of fittings out of a Special Restricted Area (Purple) is permitted **only if** those fittings have been cleaned and disinfected to remove all animal products of horses.

#### Schedule 4 – Permitted Movements of Vehicles

- 1. Movement of vehicles for or used in connection with horses is permitted <u>within</u> a Special Restricted Area (Purple).
- 2. Movement of vehicles for or used in connection with horses is permitted <u>into</u> a Special Restricted Area (Purple).
- 3. Movement of vehicles for or used in connection with horses is permitted <u>out of</u> a Special Restricted Area (Purple) **only if** the vehicle has been cleaned and disinfected to remove all animal products of horses.

#### **Definitions**

In this permit,

*Special Restricted Area (Purple)* means any restricted area that is known as a Special Restricted Area (Purple) that has been declared, or may be declared, pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza.

This Permit commences on and from 21 September 2007.
