ORDER - Section 22

Control Order - Events

I, SIMON JOHN CHARLES OLIVER, an inspector under the *Exotic Diseases of Animals Act 1991* ("the Act"), having been directed by, BRUCE MORGAN CHRISTIE, Chief Veterinary Officer, pursuant to his delegated powers under section 67 of the Act, to make the following Control Order, hereby declare:

1. pursuant to section 22(1)(a) of the Act, that the controls set out in the Schedule below apply to:

- (a) horses, mules, donkeys and other animals in the Equidae family, and
- (b) animal products of horses, mules, donkeys and other animals in the Equidae family;

in the Control Area (Amber) and the Restricted Area (Red) from the date of this Control Order until 1 October 2007.

2. where there is an inconsistency between this Control Order and any previous Control Order in relation to the controls set out in the Schedule below, this Control Order prevails.

#### SCHEDULE

- (i) The holding of markets, fairs, sales, shows, parades, race meetings or other gatherings or competitions involving animals or animal products to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer.
- (ii) The presence or exposure of animals or animal products to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer, at any place where animals or animal products are exposed for sale.
- (iii) The presence or exposure of animals to which this Order applies is prohibited, unless authorised by the Chief Veterinary Officer, at any place where animals are exposed for exhibition, parades, race meetings or any form of recreation or competition.

#### **Definitions:**

In this Control Order:

*Control Area (Amber)* means that part of the Control Area other than all Protected Areas (Green) and all Restricted Areas and known as the Control Area (Amber).

**Restricted Area** (**Red**) means a restricted area which has been declared or may be declared pursuant to section 15 of the Act, in relation to the exotic disease Equine influenza and known as a Restricted Area (Red).
