



The special significance of the Aboriginal Place include the ridge line 'high ground' meeting place for Dharawal, Gandangara and Dharug people, which was also a vantage point during the pre contact era enabling country to be observed and monitored. The place is associated with early engagement, and at times conflict, between European settlers and Aboriginal peoples. The 'vista' from the high ground provides a corridor southeast to the Georges River across remanent native vegetation and riverine environment.



I, JOHN WATSON, General Manager, Occupational Health and Safety Division of the WorkCover Authority of New South Wales, pursuant to Clauses 347 and 348 of the Occupational Health and Safety Regulation 2001, make the following Order.

Occupational Health and Safety Regulation 2001

Exemption Order No. 002/09

1. Name of Order This Order is the Occupational He

This Order is the Occupational Health and Safety Regulation 2001 Exemption Order No. 002/09.

2. Commencement

This Order commences on the 6th day of March 2009 and has effect for a period of five years from that date.

3. Exemption

This exemption applies to the setting of pressure relief valves fitted to multi-modal (ISO) tanks. The pressure setting of the relief valves fitted to these tanks may comply with the requirements of Clause 6.7.2.9.2 of the International Maritime Dangerous Goods (IMDG) Code and the Australian Code for the Transport of Dangerous Goods by Road and Rail (ADG Code) rather than that specified in AS 1210 as specified in the Occupational Health and Safety Regulation 2001, but only if the conditions specified in Schedule 2 are complied with.

#### SCHEDULE 1

This Exemption applies to Clause 94 of the Occupational Health and Safety Regulation 2001 (the Regulation), requiring designers of those items of plant listed in Clause 94 ensure that a design complies with the relevant Australian Standard listed in Schedule 1 of the Regulation.

#### SCHEDULE 2

This exemption applies to the pressure relief valve/s setting on multi-modal (ISO) portable tanks subject to the following:

1. This exemption applies only to vessels that are open vented during filling so the pressure in the vessel being filled remains near atmospheric at all time during filling, the pressure in the vessel also remains at or near 0 kPa gauge during transport.

- 2. The pressure vessel of the multi-modal portable tank is designed, manufactured and tested to AS 1210, or a pressure vessel design standard acceptable in the country of manufacture which provides an equivalent level of safety to that afforded by AS 1210, except for the setting of the pressure relief valve/s fitted which must comply with the settings required by Clause 6.7.2.9.2 of the International Maritime Dangerous Goods (IMDG) Code and The Australian Code for the Transportation of Dangerous Goods by Road & Rail (ADG Code).
- 3. The multi-modal (ISO) tank is design approved and certified by a body recognised by the International Marine Organisation (IMO).
- 4. The Multi-Modal (ISO) tank meets the requirements of the International Maritime Dangerous Goods (IMDG) Code and the Australian Code for the Transport of Dangerous Goods by Road & Rail (ADG Code).
