Proclamation No. 568-OJD

Proclamation to Restrict the Importation or Introduction into New South Wales of Sheep on account of Johne's Disease

I, Professor MARIE BASHIR, AC, CVO, Governor of the State of New South Wales, with the advice of the Executive Council:

- a. pursuant to sections 3 (2) (a) and 11B of the Stock Diseases Act 1923 ('the Act'), revoke Proclamation No. 566-OJD published in *New South Wales Government Gazette* No. 50 of 9 May 2008, at pages 3820 -3821, and any Proclamation revived as a result of its revocation; and
- b. pursuant to section 11B of the Act, and being of the opinion that certain sheep might be infected with, or might carry or spread, Johne's disease (in the form commonly known as ovine Johne's disease or OJD), restrict the importation or introduction into the State of sheep as set out in the Schedule.

SCHEDULE

Bringing of sheep into the OJD Exclusion Area of New South Wales

A person must not bring or cause or permit sheep to be brought into the part of New South Wales known as the 'OJD Exclusion Area' unless:

- (a) the sheep are accompanied by a Completed Health Statement for Sheep that is given to the person to whom the sheep are delivered; or
- (b) the sheep are exempt sheep; or
- (c) the sheep are moved in accordance with:
 - a written permit issued by an inspector under section 7 (6) of the Act, or
 - an order given by an inspector under section 8 (l)
 (b) of the Act,

in circumstances that are of a kind approved from time to time by the Executive Director of the Division of Agriculture, Biosecurity and Mine Safety or Director, Animal and Plant Biosecurity.

Bringing of sheep for sale or agistment into the OJD Management Area of New South Wales

A person must not bring or cause or permit sheep to be brought into the part of New South Wales known as the 'OJD Management Area' for sale or agistment unless:

- (a) the sheep are accompanied by a Completed Health Statement for Sheep that is given to the person to whom the sheep are delivered; or
- (b) the sheep are for sale and are exempt sheep; or
- (c) the sheep are moved in accordance with:
 - a written permit issued by an inspector under section 7 (6) of the Act, or
 - an order given by an inspector under section 8 (1) (b) of the Act in circumstances that are of a kind approved from time to time by the Executive Director of the Division of Agriculture, Biosecurity and Mine Safety or Director, Animal and Plant Biosecurity.

Definitions

In this Proclamation:

Completed Health Statement for Sheep means:

- 1. a document sourced from a booklet titled 'National Sheep Health Statement Version 1 March 2008' or from a subsequent edition approved by the Director, Animal and Plant Biosecurity, and duly completed by the owner and/or person responsible for the husbandry of the sheep; or
- 2. a document sourced electronically titled 'National Sheep Health Statement Version 1 March 2008' or from a subsequent edition approved by the Director, Animal and Plant Biosecurity, and duly completed by the owner and/or person responsible for the husbandry of the sheep; or
- 3. a document approved from time to time by the Director, Animal and Plant Biosecurity, and duly completed by the owner and/or person responsible for the husbandry of the sheep.

Executive Director of the Division of Agriculture, Biosecurity and Mine Safety means the Executive Director of the Division of Agriculture, Biosecurity and Mine Safety, of NSW Department of Primary Industries.

Director, Animal and Plant Biosecurity means the Director, Animal and Plant Biosecurity, of NSW Department of Primary Industries.

exempt sheep means:

1. sheep being moved to slaughter, directly or via a slaughter-only sale; and

2. sheep being sent or delivered to a Health Statement for Sheep exempt sale approved by a Regional Veterinary Officer or a Senior Regional Animal Health Manager no later than 48 hours before the sale.

'OJD Exclusion Area' means the part of New South Wales declared by Notification from time to time to be a Protected Area as regards Johne's disease in sheep.

'OJD Management Area' means the part of New South Wales declared by Notification from time to time to be a Protected (Control) Area as regards Johne's disease in sheep.

Regional Veterinary Officer means Regional Veterinary Officer, of NSW Department of Primary Industries.

sale includes, sell, offer for sale, assist in selling and attempt to sell.

Senior Regional Animal Health Manager means Senior Regional Animal Health Manager, of NSW Department of Primary Industries.

Notes:

Introducing sheep into New South Wales in contravention of this Proclamation is an offence under section 20 of the Act. The maximum penalty for such an offence is ordinarily \$11,000, but is \$22,000 if the sheep are diseased, and \$110,000 and 6 months imprisonment if the sheep are diseased and other sheep in the State become diseased as a result.

The doing of other things in contravention of this Proclamation is an offence under section 20H(1)(a) of the Act. The maximum penalty for such an offence is \$11,000.

OCCUPATIONAL HEALTH AND SAFETY REGULATION 2001

Exemption Order No. 009/09

I, JOHN WATSON, General Manager, Occupational Health and Safety Division of the WorkCover Authority of New South Wales, pursuant to Clause 348 of the Occupational Health and Safety Regulation 2001, make the following Order.

Explanatory Note

Clause 348 of the Occupational Health and Safety Regulation 2001 (the Regulation), provides that WorkCover may by order published in the *New South Wales Government Gazette* exempt any class of person or things from a specified provision of the Regulation.

This Order exempts:

• Principal contractors from sub-clauses 213(1) and 213(1A) of the Regulation in relation to certain persons carrying out construction work on a construction

project and the requirement for those persons to have undergone general health and safety induction training that complies with clause 217 of the Regulation;

- Employers from sub-clauses 214(1) and 214(1A) of the Regulation in relation to certain persons carrying out construction work and the requirement for those persons to have been provided with general health and safety induction training that complies with clause 217 of the Regulation;
- Certain self-employed persons from sub-clause 215(1) of the Regulation in relation to carrying out construction work and the requirement for those persons to have undergone general health and safety induction training that complies with clause 217 of the Regulation; and
- Certain persons carrying out construction work from clause 215A of the Regulation and the requirement for those persons to produce for inspection immediately an OHS induction training certificate at the direction of an inspector.

The exemption only applies in relation to holders of "Queensland White Cards". A "Queensland White Card" means:

• A "general induction card" which indicates completion of the general induction training course national unit of competency CPCCOHS1001A. The card is uniquely numbered and must bear the "Queensland Government Department of Employment and Industrial Relations" logo. The card is colloquially known as a "White Card".

The exemption also only applies in relation to obligations with respect to general health and safety induction training that complies with clause 217 of the Regulation. The exemption is granted subject to certain conditions.

Occupational Health and Safety Regulation 2001 Exemption Order No. 009/09

1. Name of Order

This Order is the Occupational Health and Safety Regulation 2001: Exemption Order No. 009/09.

2. Commencement

This Order commences on 1 July 2009 and has effect for the period up until 1 April 2010, unless sooner withdrawn by WorkCover under clause 348 (5) of the Regulation.

3. Exemption

This Order exempts:

- 1. Principal contractors from sub-clauses 213(1) and 213(1A) of the Regulation in relation to general health and safety induction training that complies with clause 217 of the Regulation for the holders of Queensland White Cards carrying out construction work on a construction project;
- 2. Employers from sub-clauses 214(1) and 214(1A) of the Regulation in relation to general health and safety induction training that complies with clause 217 of the Regulation for the holders of Queensland White Cards carrying out construction work;
- 3. Self-employed persons holding Queensland White Cards from sub-clause 215(1) of the Regulation in relation to general health and safety induction training that complies with clause 217 of the Regulation for carrying out construction work; and

- 4. Persons carrying out construction work who hold Queensland White Cards from clause 215A of the Regulation.
- 5. Conditions

This Exemption is issued subject to the following conditions:

- (1) Principal contractor
 - (i) A principal contractor for a construction project must not direct or allow another person to carry out construction work on the construction project unless the principal contractor is satisfied that the person is a holder of a Queensland White Card.
 - (ii) The only evidence on the basis of which a principal contractor may be satisfied that a person has been issued with a Queensland White Card is the production by the person of a Queensland White Card.
 - (iii) A principal contractor for a construction project must keep a copy of a Queensland White Card in relation to each relevant person carrying out construction work on the construction project, until 3 years after the project is completed.
- (2) Employer
 - (i) An employer must ensure that any employee whom the employer employs to carry out construction work is a holder of a Queensland White Card.
 - (ii) The only evidence on the basis of which an employer may be satisfied that a person has been issued with a Queensland White Card is the production by the person of a Queensland White Card.
 - (iii) An employer must keep a copy of a Queensland White Card in relation to each employee carrying out construction work, until 3 years after the employee has ceased to be employed by the employer.
- (3) Self-employed persons
 - (i) A self-employed person must not carry out construction work unless the person holds a Queensland National White Card.
- (4) Person carrying out construction work
 - (i) A person holding a Queensland White Card carrying out construction work must produce the Queensland White Card for inspection immediately when directed to do so by an inspector.
 - (ii) A person holding a current Queensland White Card carrying out construction work must also produce for inspection immediately any relevant form of identity of the person, including a sample of the person's usual signature or driver's licence, when directed to do so by an inspector.
 - (iii) A person holding a Queensland White Card carrying out construction work must not fail to comply with a direction given by an inspector under paragraphs (4)(i) and (ii) above.
- 6. Definitions

In this Order all terms and definitions are consistent with the terms and definitions contained in the Occupational Health and Safety Act 2000 and Occupational Health and Safety Regulation 2001.

OCCUPATIONAL HEALTH AND SAFETY REGULATION 2001 (Clause 348)

Exemption Order No. 004/09

Occupational Health and Safety Regulation 2001 Exemption Order No. 004/09

1. Name of Order

This Order is the Occupational Health and Safety Regulation 2001 Exemption Order No. 004/09.

- 2. Commencement
 - 1. This Order commences on the date of its gazettal, and has effect for a period of five years from that date.
 - 2. The version of this Order that was gazetted on 22 May 2009 (in *New South Wales Government Gazette* No. 75, at pages 2322 and 2323), is revoked upon commencement of this Order.
- 3. Exemption
 - 1. The Australian Gas Association, ABN 98004206044, ("AGA") is hereby exempted from clauses 129(b), 136(9) and 140(2) of the Occupational Health and Safety Regulation 2001 ("Regulation") to the extent that those clauses (directly or indirectly) require AGA to grant certificates of conformity only to gas cylinder test stations in Australia, as required by clause 3.22.1 of AS 2030.1 and clause 1.3.3 of AS 2337.1. This exemption is subject to the conditions in Part A of Schedule 1.
 - 2. A Prescribed Tester is hereby exempted from clauses 129(b), 136(9) and 140(2) of the Regulation to the extent that those clauses (directly or indirectly) require that certificates of conformity be granted only to gas cylinder test stations in Australia, as required by clause 3.22.1 of AS 2030.1 and clause 1.3.3 of AS 2337.1. This exemption is subject to the conditions in Part A of Schedule 1.
 - 3. A Prescribed User is hereby exempted from clauses 129(b), 136(9) and 140(2) (as the case may be) of the Regulation to the extent that those clauses (directly or indirectly) require that certificates of conformity be granted only to gas cylinder test stations in Australia, as required by clause 3.22.1 of AS 2030.1 and clause 1.3.3 of AS 2337.1. This exemption is subject to the conditions in Part B of Schedule 1.
- 4. Definitions
 - In this Order:

"Act" means the Occupational Health and Safety Act 2000.

"AS 2030" means Australian Standard AS 2030 – Gas Cylinders.

"AS 2337" means Australian Standard AS 2337 - Gas Cylinder Test Stations.

"Gas cylinder" has the same meaning as in the Regulation.

"Gas cylinder test station" means a facility which performs inspection and testing of gas cylinders according to the requirements of AS 2337, and includes an integrated gas cylinder test station.

"Integrated gas cylinder test station" means a test station located within a gas cylinder manufacturing facility, which is also accredited to perform inspection of the manufacturing process.

"MP 48" means the document of that title published by Standards Australia Limited from time to time.

"Prescribed Tester" means a person who has received a certificate of conformity from AGA in relation to a gas cylinder test station that is located outside Australia and is operated by that person.

"Prescribed User" means a person who:

- (a) hires or leases a gas cylinder to another person (within the meaning of clause 129(b) of the Regulation),
- (b) owns a gas cylinder affecting public safety (within the meaning of clause 136(9) of the Regulation, or
- (c) is an employer (within the meaning of clause 140(2)of the Regulation) who must ensure that a gas cylinder complies with AS 2030 Parts 1, 2 and 4 and is inspected and maintained as required by AS 2030 Parts 1, 2 and 4.

"Regulation" means the Occupational Health and Safety Regulation 2001.

"WorkCover NSW" means the WorkCover Authority of New South Wales.

5. Other laws not affected

Nothing in this Order affects any other applicable requirement imposed by the Regulation, the Act or any other law in relation to the matters connected with this Order.

6. Status of certain previous exemption orders

For the avoidance of doubt, exemption orders 021/007 and 005/08 are not affected by this Order.

SCHEDULE 1

Part A - Conditions applicable to AGA and Prescribed Testers

The exemption applying to AGA and a Prescribed Tester under this Order is subject to the following conditions:

- 1. The design of a gas cylinder which is tested by the Prescribed Tester has been registered in accordance with clause 107 of the Regulation.
- 2. The Prescribed Tester has received a current certificate of conformity granted by AGA.
- 3. The Prescribed Tester's identification stamp mark has been advised to Standards Australia Limited for listing in the next publication of MP48.
- 4. AGA must:
 - (a) maintain a current register of all Prescribed Testers and

- (b) make available, on request, details contained in the register to a regulatory authority (including WorkCover NSW).
- 5. The gas cylinders tested by a Prescribed Tester must be acceptable for sale in the country of manufacture as well as in Australia.
- 6. Documentation, in the English language, required by AS 2030.1 must be available in Australia in relation to the gas cylinders tested by the Prescribed Tester.
- 7. The Prescribed Tester must remain compliant with Appendix E of AS 2337.1.
- 8. AGA must continue to be permitted by a recognized body (within the meaning of AS 2337.1) to grant certificates of conformity to gas cylinder test stations.

Part B - Conditions applicable to Prescribed Users

The exemption applying to a Prescribed User under this Order is subject to the condition that the Prescribed User ensures that any gas cylinder to which the exemption applies bears an identification stamp mark which indicates that the gas cylinder has been tested by a Prescribed Tester.

Sporting Injuries Insurance Regulation 2009

A new Regulation is proposed to provide greater access to benefits for insured sporting organisations under the Sporting Injuries Insurance Act 1978. It is proposed to increase the reimbursement of funeral expenses from \$4,560 to \$9,000 and to reduce the level of permanent loss that is required to be suffered for a person to be eligible for a benefit in respect of the permanent loss of use of a limb from 33% to 30% and for permanent loss of hearing in both ears from 11% to 10%. The new Regulation will replace the current Regulation.
