

- (5) The scheme shall, where an approval of a modified article has been granted, provide the applicant for that approval with written notice of the granting of that approval and of the details of the modification.
- (6) The scheme shall, where an approval has been renewed, provide the applicant for that renewal with written notice of that renewal.
- (7) The scheme shall maintain a computerised record of all approvals (including modifications and renewals). The record shall contain–
 - (a) the approval particulars listed in clause 4 above;
 - (b) details of any modified or renewed approval; and
 - (c) details of any changes in the name of the approval holder, in the model reference code or in the description of an approved article.
- (8) The scheme shall provide to the Commissioner and other relevant authorities as directed, the computerised records described in item 7 above.
- (9) The scheme shall not grant an approval period (including any renewal period) of longer than five years. A modified approval shall not alter the date of expiry of the approval.
- (10) The scheme may extend an approval but only where the Commissioner's written authorisation has been provided. The extension period is determined by the Commissioner.
- (11) The scheme shall cancel or suspend an approval within five working days of written advice from the Commissioner to cancel or suspend an approval. The scheme shall advise the approval holder and other relevant authorities as directed, in a form acceptable to the Commissioner, within five working days of a cancellation or suspension.
- (12) The scheme shall advise the Commissioner and other relevant authorities as directed, in the form acceptable to the Commissioner, within five working days, of the details where it becomes aware that an article, marked with the scheme's mark, has been sold or is on sale without the approval of the scheme.
- (13) The scheme shall advise the Commissioner and other relevant authorities as directed, in the form acceptable to the Commissioner, within 5 working days, of the details of any cancellation of an approval.
- (14) The scheme shall allow the Commissioner to make an assessment of the scheme, which may include an inspection of the premises and examination of documentation in relation to the schemes approval processes and issued approvals, as determined by the Commissioner.
- (15) The scheme shall only authorise the use of the mark accepted by the Minister or the Regulatory Compliance Mark, where the requirements of all the relevant parts of AS/NZS 4417 are fulfilled, to evidence an approval of a declared article.
- (16) The scheme shall on request provide the Commissioner with all records, including test reports and photographs, submitted to the scheme

associated with an approval granted by the scheme. These records shall be maintained for at least 10 years from the date of expiry of the approval or any subsequent renewal.

(17) The scheme agrees to pay the Commissioner in accordance with the attached "Schedule of Payment".

STATUTORY AND OTHER OFFICES REMUNERATION ACT 1975

Report and Determination pursuant to section 14 of the Act REPORT:

- 1. On 2 July 2009 the Minister for Public Sector Reform, the Hon John Robertson MLC, directed the Statutory and Other Offices Remuneration Tribunal (the Tribunal), pursuant to section 14(1) of the Statutory and Other Offices Remuneration Act 1975 (the Act), to make a determination in respect of the remuneration payable to the Principal Claims Assessor under the Motor Accidents Compensation Act 1999.
- 2. For remuneration purposes the office of Principal Claims Assessor is listed in Schedule 2 of the Act. This is a new position and the Tribunal has not previously made a determination on the remuneration payable for this office.
- 3. The Principal Claims Assessor is established as a statutory office holder under the Motor Accidents Compensation Act 1999. The Principal Claims Assessor is the head of the Claims Assessment and Resolution Service (CARS) of the Motor Accidents Authority. The CARS determines certain procedural disputes in connection with motor accident claims as well as liability on the part of an insurer to pay compensation to an injured person and the amount of such compensation.
- 4. The Principal Claims Assessor is not subject to the direction or control of the Motor Accidents Authority or any public servant in relation to their assessment duties. The role of the Principal Claims Assessor is that of an independent decision maker.
- 5. The Claims Assessment and Resolution Service comprises a number of Claims Assessors (including the Principal Claims Assessor) as well as case management and administrative staff. The assessors are lawyers who are appointed due to their expertise in injury compensation law. The Principal Claims Assessor is responsible for the overall management of the Assessors and assessment process.
- 6. Claims are assessed in accordance with common law and subject to certain restrictions to benefits as outlined in the Act. The majority of claims are assessed by the Claims Assessors, under delegation from the Principal Claims Assessor. The PCA and the Assessors have unlimited monetary jurisdiction in regard to claims.

- 7. The Principal Claims Assessor also has statutory authority to exempt certain claims enabling them to proceed direct to Court without having to be assessed first. The PCA has exclusive powers in respect of the exemption of claims from assessment.
- 8. As head of the CARS the Principal Claims Assessor also undertakes the leading role in the recruitment and training of the external claims assessors, their leadership and continued development and the monitoring of their performance. The position also provides specialist professional advice internally and externally on complex or sensitive claims disputes and is primarily responsible for providing leadership and professional input into policy, Guidelines, stakeholder and Assessor management and education.
- 9. In determining the remuneration for this position the Tribunal has had regard to the enhanced role and responsibilities of the Principal Claims Assessor. The Tribunal has also had regard to the remuneration paid to other office holders with similar jurisdictional responsibilities as well as the outcome of an independent job evaluation of the position.
- 10. Having regard to the above, and having considered the views of the Assessors, the Tribunal is of the view that the Principal Claims Assessor should receive an annual salary of \$243,220 and so determines.

DETERMINATION:

Pursuant to section 14(1) of the Statutory and Other Offices Remuneration Act 1975 the Tribunal determines that the salary for Principal Claims Assessor under the Motor Accidents Compensation Act shall be \$243,220 per annum with effect from 1 July 2009.

ELECTRICITY SUPPLY ACT 1995

Section 119(1)(a)

ORDER

I, IAN MACDONALD, M.L.C., Minister for Energy, pursuant to section 119(1)(a) of the Electricity Supply Act 1995 (the Act), declare as follows:

- 1. Each electricity load used by the persons (including any related bodies corporate) specified in the Schedule (the specified person) at the locations set out in the Schedule is partially exempt from the energy savings scheme in Part 9 of the Act. The proportion of each electricity load that is exempt is specified in the Schedule as a percentage (the exempt proportion).
- 2. In applying the exemption granted by paragraph 1 of this Order a scheme participant may deduct from the total value of its liable acquisitions an allowance of 5% of the exempt proportion for losses occurring between the purchase of electricity by the scheme participant and its use by the specified person.
- 3. The exemption granted by paragraph 1 of this Order commences on 1 July 2009 and is revoked on 31 December 2009.
- 4. The Scheme Regulator, pursuant to section 120(5) of the Act, is authorised to make rules with respect to the exemption granted by paragraphs 1 and 2 of this Order (including rules relating to assessment of deductions under Division 5 of the Act).

I am satisfied that each electricity load to which this Order applies is used in connection with an industry or activity that is both emissions intensive and trade exposed and that the exemption is generally consistent with the objects of Part 9 of the Act.


