

SECTION 9(1) of the Charitable Trusts Act 1993 permits the application of property cy-pres where the spirit of the original trust can no longer be implemented.

Following the anniversary of the 2002 nightclub bombings in Kuta, Bali, in which a number of Australians were killed, the Bali Peace Park Incorporated organisation was formed. Its purpose was to raise money to establish a memorial park on the bombsite. Approximately \$17,000 was raised but this money has been diverted to other areas including a Balinese orphanage. There is now \$580.00 remaining in the Bali Peace Park Incorporated bank account.

A new organisation, called the Bali Peace Park Association Incorporated, was established in 2008 with the intention of carrying on the same, or similar, purpose as Bali Peace Park Incorporated, namely, to raise funds to buy the site of the former Sari Club nightclub and to construct a spiritual garden in memory of the victims of the bombings.

I have formed a view that the charitable purposes of both Bali Peace Park Incorporated and Bali Peace Park Association Incorporated are the same or similar in purpose, being a purpose 'beneficial to the community', which is a charitable purpose. Accordingly I consider that this is an appropriate matter in which the Attorney General should approve a cypres scheme under section 12(1)(a) of the Charitable Trusts Act 1993.

I have approved a recommendation that the Attorney General establish a cy-pres scheme pursuant to section 12 of the Charitable Trusts Act 1993 for the application of the charitable funds. Under that section, I hereby order that the \$580.00 now remaining and held by the Bali Peace Park Incorporated is to be applied by the Bali Peace Park Association Incorporated towards the purchase of the Sari Club site for the purposes of constructing a memorial garden to the victims of the 2002 Bali bombings.

This Order will take effect 21 days after its publication in the NSW Government Gazette, in accordance with section 16(2) of the Charitable Trusts Act 1993.

- Receive copies of reports as referred by the Director-General.
- 2.4 Receive copies of the reports to the Director-General prepared by the Corporate Governance and Risk Management Branch on clinical matters arising from external agencies.
- 2.5 Review and provide advice to the Director-General, Chief Executives of Public Health Organisations under the Heath Services Act 1997, and Chief Executives of facilities licensed under the Private Health Facilities Act 2007 on policy and strategy development to address issues arising from clinical incidents.
- 2.6 Establish subcommittees to assist with the functions of the Committee and delegate functions to those subcommittees as the Committee deems appropriate.
- 2.7 Obtain advice and assistance from:
 - a. Relevant Branches of the NSW Department of Health
 - b. NSW Clinical Excellence Commission
 - c. NSW Agency for Clinical Innovation
 - d. Any other person or body the CRRC considers appropriate to assist in the performance of its functions
 - e. Provide RCA Reports to other Committees authorised under Section 23 of the Health Administration Act as necessary. These committees include:
 - 1. NSW Maternal and Perinatal Committee,
 - 2. NSW Special Committee Investigating Deaths Under Anaesthesia (SCIDUA)
 - 3. The Collaborating Hospitals Audit of Surgical Mortality (CHASM)
- 2.8 Advise the NSW Department of Health Management Board and Senior Executive Advisory Board on measures to address and reduce the occurrence of serious clinical incidents.

2.9 Provide an annual report on the activities of the Committee to the Minister for Health.




