### HERITAGE ACT, 1977

Direction pursuant to section 34(1)(a) to list an item on the State Heritage Register

Catherine Hill Bay Cultural Precinct, Flowers Drive, Catherine Hill Bay

SHR No 1828

IN pursuance of Section 34(1)(a) of the Heritage Act, 1977, I, the Minister for Planning, having considered a recommendation of the Heritage Council of New South Wales, direct the Council to list the item of environmental heritage specified in Schedule "A" on the State Heritage Register. This listing shall apply to the curtilage or site of the item, being the land described in Schedule "B". The listing is subject to the exemptions from approval under Section 57(2) of the Heritage Act, 1977, described in Schedule "C" and in addition to the standard exemptions.

The item known as the Catherine Hill Bay Cultural Precinct, situated on the land described in Schedule "B".

#### SCHEDULE "B"

All those pieces or parcels of land in the Parish of Wallarah, County of Northumberland shown on the plan catalogued HC 2342 in the office of the Heritage Council of New South Wales.

#### SCHEDULE "C"

**1.** Existing approved development:

All works and activities in accordance with a current and valid development consent from Lake Macquarie City Council in force at the date of gazettal for listing the Catherine Hill Bay Cultural Precinct on the State Heritage Register.

**2.** DAs complying with the Lake Macquarie City Council Lake Macquarie Council Development Control Plan No 1 – Part 2 – Section 2.4 and its Heritage Guidelines for Catherine Hill Bay for Catherine Hill Bay.

Order under section 324 (1)

#### REPEAL OF TEMPORARY WATER RESTRICTION ORDER

Lower Namoi Regulated River Water Source

Gwydir Regulated River Water Source

PURSUANT to section 324 (1) of the Water Management Act 2000 (Act), I, DAVID HARRISS, having delegated authority from the Minister for Water, do, by this Order, repeal the order made under former section 323 of the Act dated 10 August 2006 and published in the New South Wales Government Gazette number 168 at page 10140 on 1 December 2006, which prohibited the taking of water under supplementary water access licences from the Lower Namoi Regulated River Water Source and from the Gwydir Regulated River Water Source except where water was announced as available to be taken.

This Order takes effect on the date that notice of the order is first published.
