## SPECIAL SUPPLEMENT

### FAIR TRADING ACT 1987

Interim Prohibition Order

Section 30 (1)

I, LINDA BURNEY, Acting Minister for Fair Trading,

1. noting that I propose to refer, to the Products Safety Committee, for consideration the question whether the supply of goods of the kind specified in the Schedule (“the Goods”) should:
    - (a) because they are dangerous, or are a possible source of danger, be prohibited; or
    - (b) be allowed only subject to conditions or restrictions to be specified by the Committee,
 and
  2. considering that the Goods are so dangerous that their supply should, in the interests of public safety, be prohibited immediately,
- hereby:
3. prohibit, pursuant to section 30 (1) of the Act, the supply of the Goods; and
  4. declare that this Order shall expire three (3) months after the date of its publication in the *New South Wales Government Gazette*.

### SCHEDULE

Goods of the type commonly known as LPG cabinet heaters, including but not limited to the heater known as the “RANA room heater”.

#### Interpretation

In this Order:

“*gas container*” includes a gas cylinder and a gas tank;

“*LPG cabinet heater*” means a portable heater that is designed to be connected to a liquid petroleum gas container with a water capacity of 25 litres or less.
