PUBLIC NOTICE

Proposed Declaration of Public Lands for Hunting Game

NOTICE is hereby given in accordance with clause 20 of the Game and Feral Animal Control Regulation 2004 of a proposed declaration under section 20 (Declaration of public land available for hunting game) of the Game and Feral Animal Control Act 2002. The public lands described below are proposed to be declared available for hunting to assist in the management and control of game and feral animals on and from 1 December 2011 to 30 November 2021.

- Have written permission from the manager of the land concerned pursuant to Clause 1 (1) of the Game and Feral Animal Control Regulation 2004.
