FISHERIES MANAGEMENT ACT 1994

Section 8 Notification - Fishing Closure

Fingal Bay Beach

I, GEOFF ALLAN, Acting Executive Director, Fisheries NSW, with the delegated authority of the Minister for Primary Industries and the Director-General pursuant to sections 227 and 228 of the Fisheries Management Act 1994 ("the Act") and pursuant to section 8 of the Act do by this notification prohibit the taking of the species of fish specified in Column 1 of the Schedule by all recreational fishers, by the methods of fishing specified in Column 2 of the Schedule, from the waters described in Column 3 of the Schedule.

This fishing closure is effective for a period of three years from the date of publication of this notification, unless sooner amended or revoked.

FISHERIES MANAGEMENT ACT 1994

Section 8 Notification - Commercial Fishing Closure

Ex-HMAS Adelaide Reserve

I, KATRINA HODGKINSON, M.P., Minister for Primary Industries, pursuant to section 8 of the Fisheries Management Act 1994 ("the Act"), do by this notification prohibit the taking of all species of fish by all methods of fishing by all endorsement holders in the Ocean Hauling Fishery, Ocean Trap and Line Fishery, Ocean Trawl Fishery, Abalone Fishery, Lobster Fishery and Sea Urchin and Turban Shell Fishery from the waters described in the Schedule to this notification.

SCHEDULE

The whole of the waters bound within the following co-ordinates:

- (a) 33 27.887'S, 151 27.301'E
- (b) 33 27.767'S, 151 27.374'E
- (c) 33 27.852'S, 151 27.574'E
- (d) 33 27.973'S, 151 27.502'E

In this Schedule, latitude and longitude coordinates are in WGS 84 Datum.

In this fishing closure:

Abalone Fishery, Lobster Fishery, Ocean Hauling Fishery, Ocean Trap and Line Fishery and Ocean Trawl Fishery mean the share management fisheries of those names, as described in Schedule 1 to the Act.

Sea Urchin and Turban Shell Fishery means the fishery declared in clause 155 of the Fisheries Management (General) Regulation 2010 to be a restricted fishery.

The provisions of this fishing closure in respect of endorsement holders in the Ocean Hauling Fishery, Ocean Trap and Line Fishery and Ocean Trawl Fishery have effect despite any provision in the Fisheries Management (Ocean Hauling Share Management Plan) Regulation 2006, Fisheries Management (Ocean Trap and Line Share Management Plan) Regulation 2006 or Fisheries Management (Ocean Trawl Share Management Plan) Regulation 2006, respectively.

This fishing closure is effective for a period of five years from the date of publication of this notification, unless sooner amended or revoked.
