# SPECIAL SUPPLEMENT

#### STOCK DISEASES REGULATION 2009

Order Pursuant to Clause 14

Exemption from Requirement to have a Property Identification Code

I, BRUCE MORGAN CHRISTIE, Executive Director, Biosecurity NSW of the Department of Trade and Investment, Regional Infrastructure and Services, with the delegated authority of the Director General of the Department of Trade and Investment, Regional Infrastructure and Services in pursuance of section 22C of the Stock Diseases Act 1923 ("the Act"), and in pursuance of clause 14 of the Stock Diseases Regulation 2009 ("the Regulation"), grant an exemption from the requirements of clause 37 of the Regulation from 1 September 2012 to those persons specified in the Schedules below.

### **SCHEDULE**

Exemption from requirement to have a property identification code

- 1. (Poultry excluding emus or ostriches) The person is:
  - (i) the owner or person in charge of poultry, excluding emus or ostriches, who has less than 100 poultry, excluding emus or ostriches, on the property; and
  - (ii) no other stock are held in captivity on the property.
- 2. (Emus or ostriches) The person is:
  - the owner or person in charge of emus or ostriches, who has less than 10 emus or ostriches on the property;
    and
  - (ii) no other stock are held in captivity on the property.
- 3. (Veterinary practices) The person is the owner or person in charge of the veterinary practice which administers treatment to stock brought to the veterinary practice but where the stock do not stay overnight at the veterinary practice and return to their property of origin or move to another property after treatment.
- 4. (Veterinary laboratories) The person is the owner or person in charge of the veterinary laboratory which receives live animals, to be euthanased, and carcasses for testing and post-mortem examination.
- 5. (Licensed Exhibits) The person is the owner or person in charge of stock lawfully held or exhibited at an animal display establishment that is licensed under the Exhibited Animals Protection Act 1986.

## **Definitions:**

In this Order:

"stock" means bison, buffalo, camelids, cattle, deer, equines, goats, pigs, poultry and sheep

"camelids" means members of the family camelidae, including camels, alpacas, llamas, vicunas and guanacos

"poultry" means chickens, turkeys guinea fowl, ducks, geese, quails, pigeons, pheasants, partridges, emus or ostriches

"equines" means members of the family equidae, including horses, donkeys, asses, mules and zebras
