






Figure 3.1 Layout Option 1, Overview




Figure 3.2 Layout Option 2, Overview (A3 size versions of these Figures are displayed in Volume 2)



The NSWTAG's proposed scheme is for the trust funds to be applied by Disability Services Australia for the purchase of seizure sensor mats and/or for the installation of soft fall flooring to assist persons suffering from epilepsy. Epilepsy Australia's proposal was for the funds to be applied for the purpose of community outreach programs and/or funding therapy camps for persons suffering from epilepsy.

The Solicitor General, as delegate of the Attorney General in Charitable Trusts Act 1993 matters, has determined that this is an appropriate matter in which the Attorney General should approve a cy-près scheme under section 12 (1) (a) of the Charitable Trusts Act 1993. The cy-près scheme requires that the trust property be applied, in equal shares, cy-près, as follows:

- 1. To the Epilepsy Association for the purpose of funding community outreach programs and/or for funding therapy camps for persons suffering from epilepsy; and
