Explanatory note

This order is made under section 49A of the *Water Management Act 2000*. The object of this order is to suspend the operation of clauses 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22 of clause 15 of the *Water Sharing Plan for the Macquarie and Cudgegong Regulated Rivers Water Source 2003* until 30 June 2016. The concurrence of the Minister for the Environment was obtained prior to the making of this order.

1 Name of Order

This order is the *Suspension of Clauses 10 to 22 of Clause 15 of the Water Sharing Plan for the Macquarie and Cudgegong Regulated Rivers Water Source Order 2015*.

2 Commencement

This order commences on the day on which it is published on the NSW legislation website and will remain in force until 30 June 2016 unless it is repealed or modified by order before that date.

3 Suspension

Clauses 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21 and 22 of Clause 15 of the *Water Sharing Plan for the Macquarie and Cudgegong Regulated Rivers Water Source 2003* are suspended.

Under the heading “Motor Sports (World Rally Championship) Act 2009 Schedule Order Declaring the Rally Area under the Motor Sports (World Rally Championship) Act 2009”, folios 2462–2474 of the *NSW Government Gazette* of 7 August 2015 have been revised as follows:

 - o Reference to Store Road should be deleted and replaced with Boyds Road.

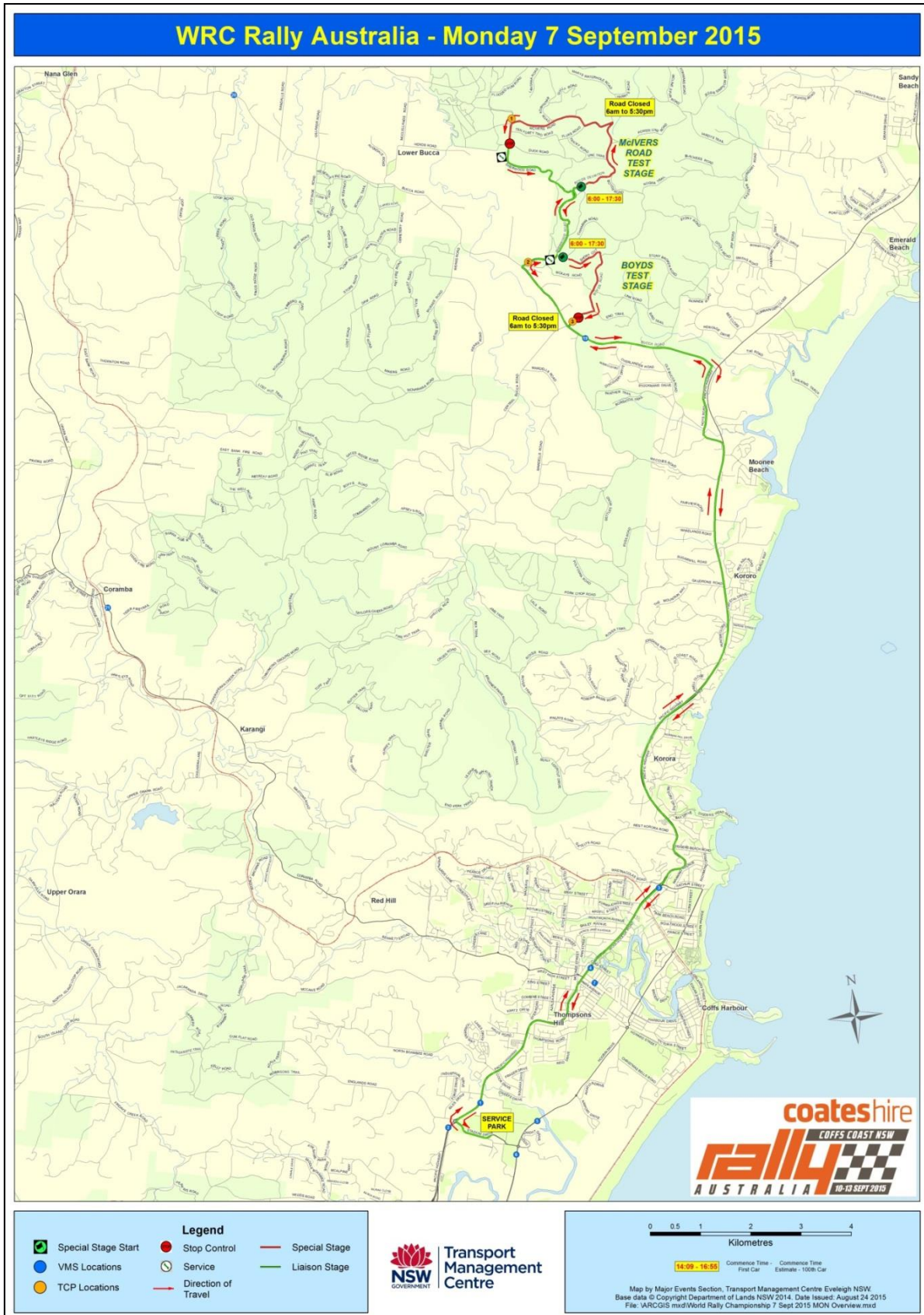
