1. Appointment of additional Administrator

Dennis Palmer is appointed as an additional Administrator of Cootamundra-Gundagai Regional Council.

2. Functions of the additional Administrator

The additional Administrator is to exercise the functions specified in clause 8 (1A) (c) of the *Local Government (Council Amalgamations) Proclamation 2016* in relation to Goldenfields Water County Council.

3. Functions of the current Administrator

The current Administrator of Cootamundra-Gundagai Regional Council, Christine Ferguson, continues to have all the functions of an Administrator under the *Local Government (Council Amalgamations) Proclamation 2016* other than the functions specified in clause 2 of this Order.

1. Appointment of additional Administrator

2. Functions of the additional Administrator

The additional Administrator may exercise the functions (including the voting rights) specified in clause 8 (1A) (c) of the *Local Government (Council Amalgamations) Proclamation 2016* that would be able to be exercised by one of the two persons that may be elected to the governing body by the new council to the Goldenfields Water County Council.

3. Functions of the current Administrator

The current Administrator of Hilltops Council, Wendy Tuckerman, continues to have all the functions of an Administrator under the Local Government (Council Amalgamations) Proclamation 2016 other than the functions specified in clause 2 of this Order.

To avoid doubt, the current Administrator may also exercise the functions (including the voting rights) specified in clause 8 (1A) (c) of the *Local Government (Council Amalgamations) Proclamation 2016* that would be able to be exercised by one of the two persons that may be elected to the governing body by the new council to the Goldenfields Water County Council.
