LOCAL GOVERNMENT ACT 1993

Order Pursuant to Section 438W

I, Paul Toole, Minister for Local Government, having:

- (a) appointed Mr Richard Beasley SC to hold a Public Inquiry into Auburn Council (Council); and
- (b) taken into account matters raised by Council in its letter of 29 January 2016 in response to the notice of intention to suspend the Council which was issued on 21 January 2016,

consider that it is on balance in the public interest to suspend the Council, and make this suspension order pursuant to section 438W to suspend the Council.

Unless terminated earlier in accordance with the Act, the suspension will terminate no later than 30 days after the date the report of the Public Inquiry is provided to me.

Pursuant to section 438Y of the Local Government Act, Mr Viv May is appointed as interim Administrator of Auburn City Council for the period during which the Council is suspended, commencing on the date of the publication of this order in the Gazette and shall have the following functions:

- To perform the role and function of the governing body of the Council under the Local Government Act and any other Act.
- To exercise the role of the governing body and councillors identified in sections 223, 232(1) and 226 of the Local Government Act.

Pursuant to section 438Y (7) of the Local Government Act, the interim Administrator shall be paid a salary of \$4305 per week from the Council's funds for the period of the suspension.

This Order takes effect upon publication in the New South Wales Government Gazette.

LOCAL GOVERNMENT ACT 1993

Order Pursuant to Section 438W

I, Paul Toole, Minister for Local Government, having:

- (a) appointed Mr Anthony Hudson to hold a Public Inquiry into Murray Shire Council (Council); and
- (b) taken into account matters raised by Council in its letter of 4 February 2016 in response to the notice of intention to suspend the Council which was issued on 28 January 2016,

consider that it is on balance in the public interest to suspend the Council, and make this suspension order pursuant to section 438W to suspend the Council.

Unless terminated earlier in accordance with the Act, the suspension will terminate no later than 30 days after the date the report of the Public Inquiry is provided to me.

Pursuant to section 438Y of the Local Government Act, Mr David Shaw, is appointed as interim Administrator of Murray Shire Council for the period during which the Council is suspended, commencing on the date of the publication of this order in the Gazette and shall have the following functions:

- To perform the role and function of the governing body of the Council under the Local Government Act and any other Act.
- To exercise the role of the governing body and councillors identified in sections 223, 232 (1) and 226 of the Local Government Act.

Pursuant to section 438Y (7) of the Local Government Act, the interim Administrator shall be paid a salary of \$2103 per week from the Council's funds for the period of the suspension.

This Order takes effect upon publication in the New South Wales Government Gazette.
