# Explanatory note

The object of this Order is to extend the accreditation of three districts of Community Services (Mid North Coast District, Western NSW District and Murrumbidgee District) as a designated agency to 1 December 2016.

The Children's Guardian is of the opinion that, as a result of changes or proposed changes to the administration of out-of-home care under the *Children and Young Persons* (Care and Protection) Act 1998, it is appropriate for the accreditation to continue in effect for the above named three districts until that date.
