#### 1 Name of Direction

This Direction is the *Environmental Planning and Assessment (Local Infrastructure Contributions) Amendment Direction 2018*.

#### 2 When Direction takes effect

This Direction takes effect on and from its date of publication in the Gazette.

#### 3 Consent authorities to which Direction is given

- (1) This Direction is given to the following councils:
  - (a) Blacktown City Council,
  - (b) Lake Macquarie City Council.
- (2) This Direction also applies to a Sydney planning panel, joint regional planning panel or local planning panel when exercising consent authority functions of one or more councils.

#### 4 Amendment of *Environmental Planning and Assessment (Local Infrastructure Contributions) Direction 2012*

The *Environmental Planning and Assessment (Local Infrastructure Contributions) Direction 2012* is amended as set out in Schedule 1.

#### Schedule 1 Amendments

##### [1] Clause 3

Omit “Sydney planning panel or joint regional planning panel” from clause 3 (2). Insert instead “Sydney planning panel, joint regional planning panel or local planning panel”.

##### [2] Clause 6D

Insert after clause 6C:

##### **6D Raising cap in Riverstone East, Blacktown LGA, after 2018 amendment direction**

- (1) This clause applies (instead of clause 6) to a development consent to the extent that the consent relates to rezoned land in Riverstone East (within Blacktown local government area) and authorises one or more dwellings on the land or subdivision of the land into residential lots.
- (2) A council or planning panel must not grant development consent that is subject to a condition requiring the payment of a monetary contribution that exceeds:
  - (a) if the contributions plan that applies to the development is an IPART reviewed contributions plan when development consent is granted – the amount specified in the table below for the relevant period, and
  - (b) in any other case – \$30,000 for each dwelling or each residential lot.
 (The relevant period is the period in which development consent is granted.)

	Relevant period	Maximum amount of contribution
1	1 January 2018 to 30 June 2018	\$35,000 for each dwelling or each residential lot

	<b>Relevant period</b>	<b>Maximum amount of contribution</b>

3	1 July 2019 to 30 June 2020	\$45,000 for each dwelling or each residential lot
4	On and from 1 July 2020	An amount determined in accordance with the applicable contributions plan

- (3) In this clause, **rezoned land in Riverstone East** means the land identified by pink hatching and the letter “F” within Riverstone East Precinct on the North West Growth Centre Land Application Map (as land to which Blacktown Growth Centres Precinct Plan 2013 applies), adopted by *State Environmental Planning Policy (Sydney Region Growth Centres) 2006* as at 22 August 2016.

**Note.** The relevant land application map sheets identifying the land within Riverstone East Precinct in the North West Growth Centre to which the above SEPP applies are LAP\_004, LAP\_008 and LAP\_009.

**[3] Clause 9**

Insert at the end of clause 9 (1) (c):

- (d) *Environmental Planning and Assessment (Local Infrastructure Contributions) Amendment Direction 2018*.

**[4] Schedule 1**

Omit item 9 (b) (relating to Lake Macquarie local government area) and insert instead:

- (b) the Belmont Catchment in the *Lake Macquarie Section 94 Contributions Plan No. 1 – Citywide – Belmont Catchment Residential (2004) as Amended* (as at 1 December 2017), or

##### Location

Clarence River, Grafton – adjacent to Memorial Park to a position approximately 2.5km upstream north of Susan Island

##### Duration

7.00am to 5.00pm – Sunday 4 March 2018

##### Detail

A rowing regatta will be conducted on the navigable waters of Clarence River at the location specified above.

An **EXCLUSION ZONE** is specified during the event. The area will be marked by buoys and patrolled by control vessels.

Unauthorised vessels and persons are prohibited from entering the exclusion zone during the times specified above.

All vessel operators and persons in the vicinity of the event must keep a proper lookout, keep well clear of competing and support vessels, and exercise extreme caution.

A **TRANSIT LANE** will be established, within which control vessels may, at times during the event, authorise vessel traffic to pass through and within the confines of the transit lane.

**SPECIAL RESTRICTIONS** apply to vessels using the transit lane. Vessels navigating through the transit lane must do so at a safe speed, must produce minimal wash, and must comply with any directions given by control vessels.

#### REGULATION OF VESSELS – EXCLUSION ZONE

##### **Location**

Farm Cove, Sydney Harbour.

##### **Duration**

Monday 26 February 2018 to Saturday 5 May 2018

##### **Detail**

The Handa Opera event will be taking place on Sydney Harbour between the above specified dates, which will involve a construction period, a performance period including small fireworks displays, and then a period during which the infrastructure will be removed. For the Duration – in order to safeguard the works and performances and to assist navigation – Roads and Maritime has specified an Exclusion Zone is to surround the area.

The **EXCLUSION ZONE** will be marked by lit yellow buoys and patrolled by control and security vessels. The zone will be in force:

- 24 hours per day – during the construction period from Monday 26 February to Wednesday 21 March 2018;
- 5.30pm to 11.30pm – during performances from Wednesday 21 March to Sunday 22 April 2018; and
- 24 hours per day – during the deconstruction period from Monday 23 April to Saturday 5 May 2018

NO UNAUTHORISED VESSELS OR PERSONS are to enter the Exclusion Zone under any circumstances.

Vessel operators should also keep clear of two lit yellow buoys placed approximately 100 metres to the south-west and north-west of the stage to allow fireworks barges to be moored each evening during performances.

All vessel operators and persons using the vicinity must keep a proper lookout, keep well clear of the works, and exercise extreme caution when navigating near the exclusion zone.

Penalties may apply (section 12(5) – *Marine Safety Act 1998*).

## ROAD TRANSPORT (DRIVER LICENSING) REGULATION 2017

### EXEMPTION ORDER

#### Clause 79(1)

I, Julie Morgan, Director Insights and Education, a delegate of Roads and Maritime Services (RMS), pursuant to clause 79(1) of the *Road Transport (Driver Licensing) Regulation 2017* (the Regulation), hereby EXEMPT applicants wishing to participate in authorised rider training courses from compliance with clause 77(1) of the Regulation to the extent that applicants are:

- (a) Required to apply to RMS in order to undertake the course, in an approved form; and
- (b) Required to pay RMS the applicable fee for the course.

Pursuant to clause 79(2) of the Regulation, this Exemption Order is conditional on an application to undertake an authorised rider training course and payment of the applicable fee being made directly to the rider training operator in accordance with business rules established by RMS, and as set out on the RMS website.

This Exemption does not apply in any individual case where RMS has expressed in writing that it does not apply with respect to a particular applicant.

#### **Object**

The Object of this Exemption Order is to facilitate the transition of authorised rider training courses to a competency based assessment scheme under clause 59 of the Regulation by allowing applications and fees to be paid directly to rider training operators in accordance with business rules established by RMS, and to streamline processes by reducing points of contact for scheme participants.

#### **Definitions:**

For the purposes of this Exemption Order, “*authorised rider training course*” and “*rider training operator*” are as defined in clause 72 of the Regulation.

#### **Publication**

This Order is published in the NSW Government Gazette.

This Order takes effect on 1 March 2018 and will continue in force until revoked, or until the repeal of Part 10 of the Regulation – whichever occurs first.

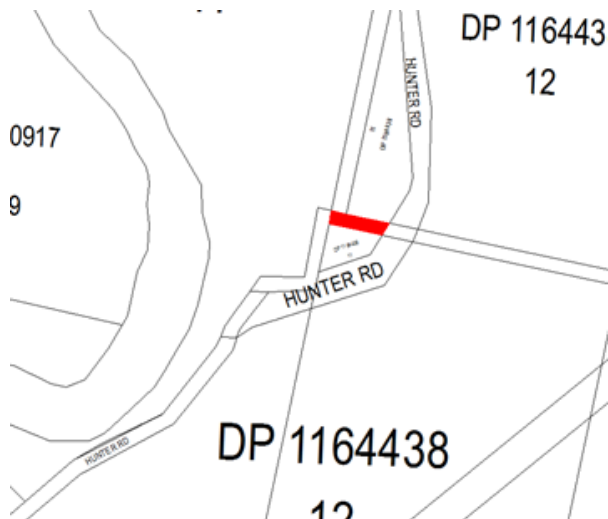

This Order commences on the day on which notice of the Order is first published in accordance with section 324 (3) of the *Water Management Act 2000* and will remain in force until 30th June 2024, unless it is repealed or modified by further order before that date.

#### 3 Repeal of previous order

This Order repeals the order made under the former section 323 of the *Water Management Act 2000* dated 24 August 2006 and published in the NSW Government Gazette on 1 September 2006 at page 7774.

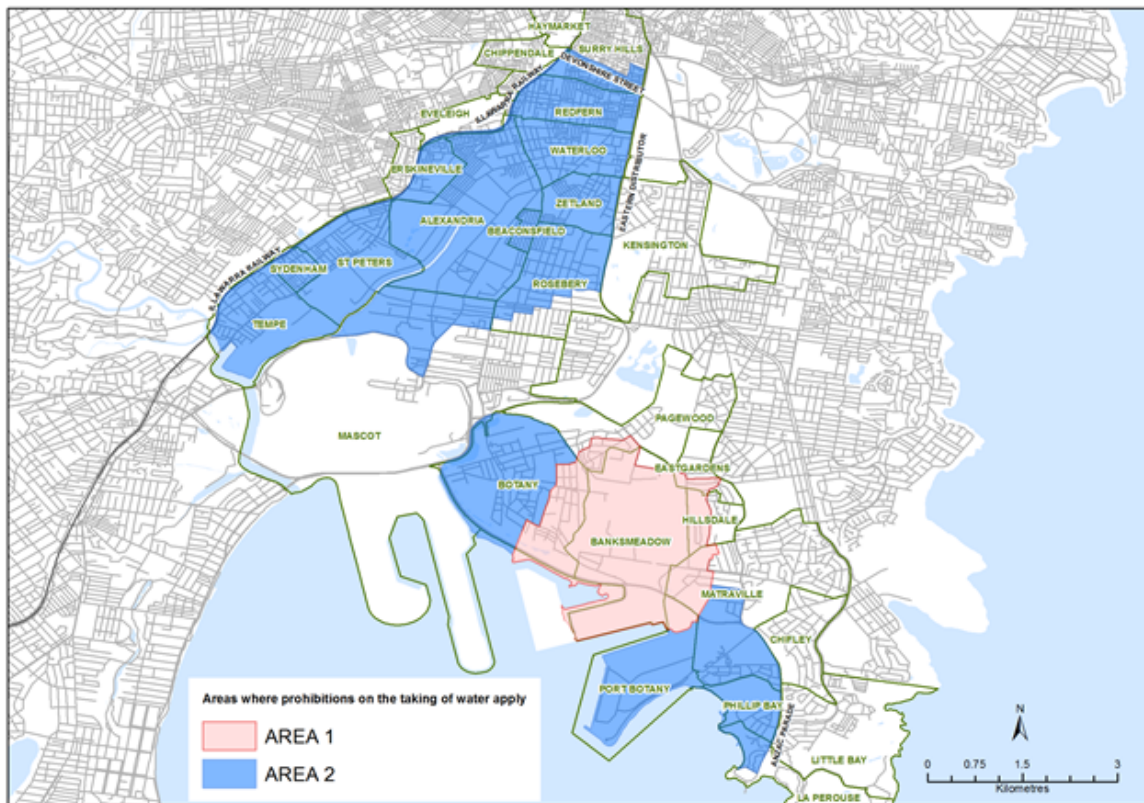
#### 4 Temporary water restrictions

The taking of water from the water source specified in Schedule 1 is prohibited as specified in Schedules 2 and 3.

#### Schedule 1 Water Source

This Order applies to those parts of the Botany Sands Groundwater Source identified within Area 1 and Area 2 on Map A to this Schedule. The Botany Sands Groundwater Source is identified in the *Water Sharing Plan for the Greater Metropolitan Region Groundwater Sources 2011*.

## Schedule 2 Prohibitions in Area 1

1. The taking of water from those parts of the Botany Sands Groundwater Source within Area 1 on Map A is prohibited.
2. The prohibition in paragraph (1) does not apply to:
  - a. the taking of water for remediation, temporary construction dewatering, testing or monitoring purposes; or
  - b. the taking of water using a water supply work nominated by water access licence 24611, 24613, 24566, 24600, 24564, 24583, 24545, or 24588, provided that the water is *fit for purpose*.
3. A person taking water under paragraph (2)(b) must:
  - a. keep records of all testing of water undertaken for the duration of this order; and
  - b. provide to an authorised officer, within 7 days of a request, written details of the results of any testing of water undertaken as requested by that officer.
4. In this Schedule:
  - a. *Fit for purpose* means:
    - i. There is a site testing plan certified by a site auditor accredited under the *Contaminated Land Management Act 1997* as being appropriate to determine if the groundwater is safe and suitable for its intended use. This site testing plan must be certified and in place prior to water being used, and
    - ii. The site testing plan includes for each proposed use of water the method of sampling, method of testing, frequency of testing, the analytes to be tested and the prescribed threshold level for each analyte above which water must not be taken, and
    - iii. Once sampled in accordance with the site testing plan, a consultant certified under a NSW Environment Protection Authority (NSW EPA) recognised contaminated land consultant certification scheme ('the consultant') must assess the results and provide a written record as to whether the groundwater is safe and suitable for its intended use as defined in the site testing plan, and

iv. All works in relation to the preparation and implementation of the site testing plan must be carried out consistent with guidelines made or approved by the EPA under section 105 of the *Contaminated Land Management Act 1997*.

b. *Authorised officer* has the same meaning it has under the *Water Management Act 2000*.

### Schedule 3 Prohibitions in Area 2

1. The taking of water from those parts of the Botany Sands Groundwater Source within Area 2 on Map A is prohibited for any of the following purposes:
  - a. human consumption;
  - b. consumption by animals;
  - c. domestic purposes;
  - d. any other purpose.
