REGULATION OF VESSELS –SPECIAL RESTRICTIONS

Location

Swan Hill Bridge, Murray River – 150 metres upstream and downstream of the Swan Hill Bridge, Swan Hill.

Duration

Wednesday 7 March 2018 to Friday 1 June 2018.

Detail

Maintenance works will be conducted on the Swan Hill Bridge between the above times, affecting safe navigation on the Murray River.

Vessel operators are advised divers will be in the water during the works and vessels associated with the diving operations will be displaying an Alpha Flag (a white and blue flag with the blue section featuring a swallow tail).

The above location will be regulated by additional special restrictions, applicable within a marked area (local buoyage and signage).

During daylight hours a closed (blocked) channel will be marked by a series of three shapes in a vertical line comprising ball – triangle – ball, and during the night, or at times of restricted visibility, by a series of three lights in a vertical line comprising red – green – red.

All vessel operators are required to comply with the Special Restrictions outlined below.

All vessel operators and persons using the waters specified above should keep a proper lookout, comply with local buoyage and signage, and exercise extreme caution when navigating near the works.

Special Restrictions

Pursuant to section 12(3) of the *Marine Safety Act 1998*, special restrictions apply to all vessels navigating within the marked area as follows

- A maximum speed of four knots; and
- A ‘no wash’ zone is imposed.

Penalties may apply (section 12(5) – *Marine Safety Act 1998*).

Lake Illawarra – extending from the shoreline of Burroo Point near the land-based locality of Ski Way Park at Oak Flats.

7.00am to 3.30pm Saturday 3 March 2018.

Detail

Dragon Boat racing will be held at the location between the above times.

An **EXCLUSION ZONE** is specified during the event and will be created at the location, comprising a square shape approximately 250 metres by 250 metres, including all navigable waters around the public boat ramp and jetties. This will mean that access to and from these facilities will not be available.

Dragon Boats will be competing inside the Zone on a 200 metre long course. Buoys will be in place indicating the start and finish of the course, and the Zone will be monitored by control vessels.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone.

All vessel operators and persons using the waters of Lake Illawarra in the vicinity of the event should keep a proper lookout, keep well clear of competing and support vessels, and exercise extreme caution.

MARINE SAFETY REGULATION 2016 APPROVAL OF LIFEJACKET STANDARDS

1 Name of Instrument

This Instrument is the *Prevention of Cruelty to Animals Instrument of Delegation 2018*.

2 Commencement

This Instrument commences on the day on which it is signed and will remain in force until it is revoked, whether in whole or in part.

3 Interpretation

(1) In this Instrument:

function includes a power, authority or duty, and exercise a function includes perform a duty.

role includes office.

role title includes title of an office.

the Act means the *Prevention of Cruelty to Animals Act 1979*.

the Department means the NSW Department of Industry.

the Regulation means the *Prevention of Cruelty to Animals Regulation 2012*.

(2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act have the same meaning in this Instrument.

(3) Unless otherwise specified, references to a role or role title in this Instrument are references to a role or role title within the Department.

(4) The summary of a function delegated in Column 2 of Schedules 1 and 2 is only for general explanation and does not limit the delegation of functions under the provisions identified in Column 1 of the Schedules.

4 Delegation of functions

(1) Pursuant to section 34C of the Act and subject to clause 4(2) below:

(a) all of the functions conferred or imposed on the Secretary under the Act (other than the power of delegation) and the Regulation are delegated to the person assigned to the role having the title Director General, NSW Department of Primary Industries;

(b) the functions conferred or imposed on the Secretary under the following legislation are delegated to any person assigned to the role having the title specified opposite in Column 3 of Schedules 1 and 2 respectively:

(i) the Act as specified in Column 1 of Schedule 1; and

(ii) the Regulation as specified in Column 1 of Schedule 2.

- (2) The person assigned to the role having the title Director General, NSW Department of Primary Industries or the role having the title specified in Column 3 of Schedule 1 or 2, includes any person who is for the time being acting in that role or performing the duties and responsibilities of that role.

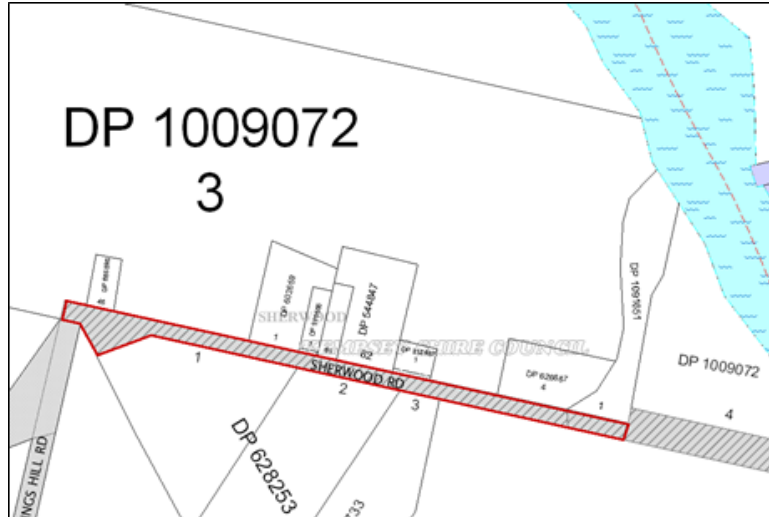
