Order conferring biodiversity certification – El Caballo Blanco, Gledswood and Camden Lakeside residential estate.

Under section 126H of the *Threatened Species Conservation Act 1995*

Under section 126H of the *Threatened Species Conservation Act 1995 (the Act)*, I Anthony Lean Chief Executive as delegate for Minister administering that Act, confer biodiversity certification on the specified land.

Under section 126P of the Act, I have determined on the basis of a biodiversity certification assessment that the overall effect of biodiversity certification is to improve or maintain biodiversity values.

Under section 126Y of the Act, I specify the measures listed in Schedule 3 as approved measures under this biodiversity certification.

Under section 126Z of the Act, I identify the parties to the biodiversity certification in Schedule 4.

Under section 126ZA of the Act, biodiversity certification of the specified land takes effect from the date of publication of this order in the NSW Government Gazette and remains in force indefinitely.

*Note: This order is made in relation to an application for biodiversity certification made under Part 7AA of the Act (**Application**) which had not been determined on the repeal of the Act. For the purposes of clause 36(2) of the Biodiversity Conservation (Savings and Transitional) Regulation 2017, I am satisfied that the Application substantially complies with Part 7AA of the Act. In accordance with clause 36 of the Biodiversity Conservation (Savings and Transitional) Regulation 2017, the biodiversity certification is taken to be biodiversity certification conferred on the specified land under Part 8 of the Biodiversity Certification Act 2016 (NSW).*

In this order “**specified land**” means the land described in Schedule 1 to this order that is also marked as “Land to be Certified” shown in pink on the map in Schedule 2.

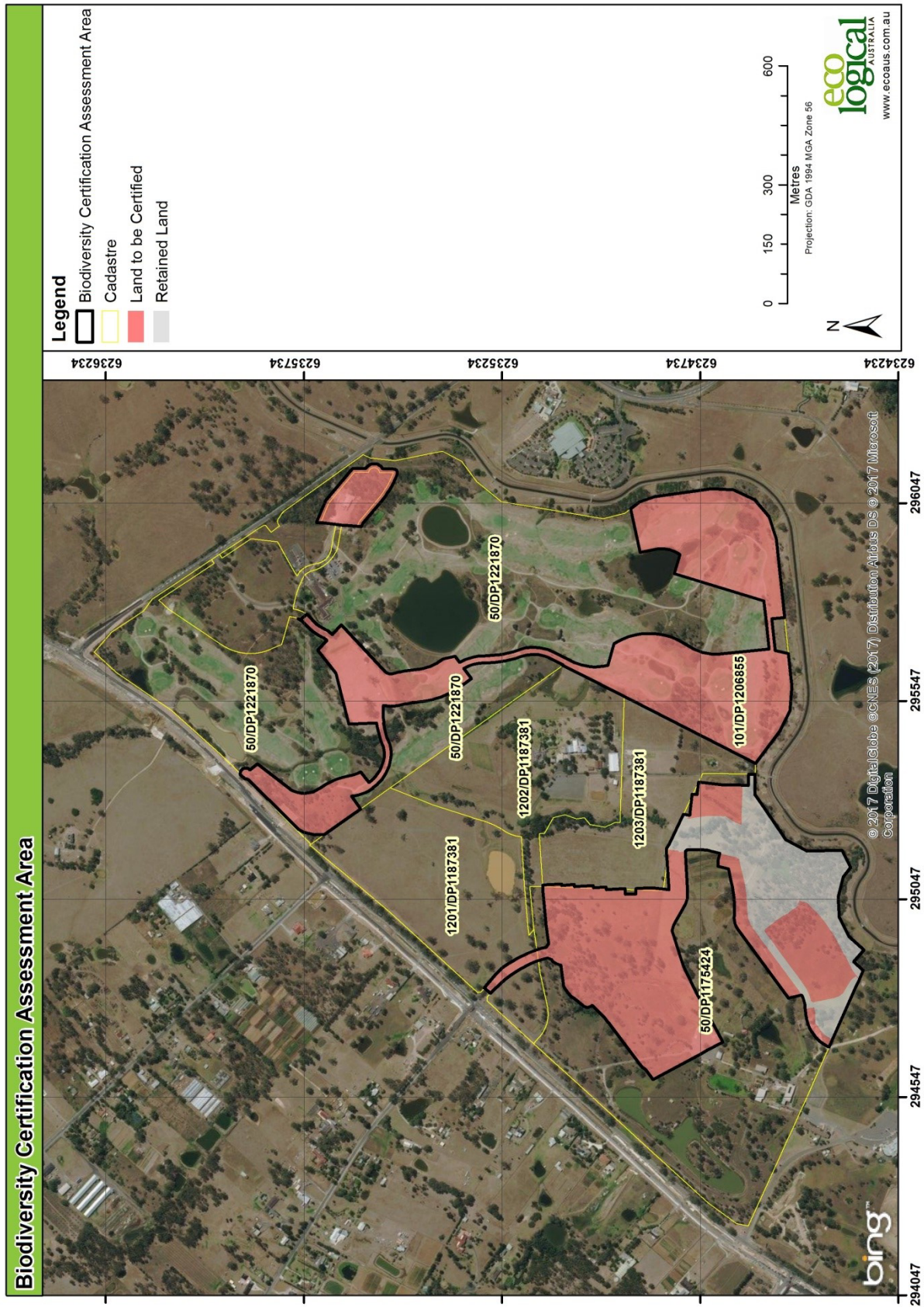

Declaration of significantly contaminated land

(Section 11 of the *Contaminated Land Management Act 1997*)

Declaration Number 20181105; Area Number 3417

The Environment Protection Authority (EPA) declares the following land to be significantly contaminated land under the *Contaminated Land Management Act 1997* ("the Act"):

1. Land to which this declaration applies ("the site")

This declaration applies to 321 Gardeners Road, Rosebery (described as Lot 100 in DP1088772) in the local government area of Bayside Council. A map of the site is attached.

2. Nature of contamination affecting the site:

The EPA has found that the site is contaminated with the following substances ("the contaminants"):

- Petroleum hydrocarbons including total recoverable hydrocarbons (TRH) and benzene, toluene, ethylbenzene and xylenes (BTEX).

3. Nature of harm that the contaminants have caused:

The EPA has considered the matters in section 12 of the Act and for the following reasons has determined that the land is contaminated and that the contamination is significant enough to warrant regulation under the Act:

- Groundwater was found to be impacted with petroleum hydrocarbons (benzene, toluene, ethylbenzene and xylenes) at concentrations exceeding the groundwater investigation levels for protection of drinking water;
- Groundwater impact has not been delineated off-site to the south or south-west of the site. Migration of the contamination is likely to have occurred given the site overlies the Botany Sand Beds Aquifer which has a high hydraulic conductivity; and
- Potentially complete exposure pathways have been identified for off-site receptors, including users of groundwater for domestic purposes.

4. Further action under the Act

The making of this declaration does not prevent the carrying out of voluntary management of the site and any person may submit a voluntary management proposal for the site to the EPA.

5. Submissions invited

The public may make written submissions to the EPA on:

- Whether the EPA should issue a management order in relation to the site; or
- Any other matter concerning the site.

If management of the site or part of the site is required, the EPA may issue a management order under s.14 of the Act.

Amendment/Repeal

This declaration may be amended or repealed. It remains in force until it is otherwise amended or repealed. The subsequent declaration must state the reasons for the amendment or repeal (s.44 of the Act).

Information recorded by the EPA

Section 58 of the Act requires the EPA to maintain a public record. A copy of this significantly contaminated land declaration will be included in the public record.

Information recorded by councils

Section 59 of the Act requires the EPA to give a copy of this declaration to the relevant local council. The council is then required to note on its planning certificate issued pursuant to s10.7 of the *Environmental Planning and Assessment Act 1979* that the land is declared significantly contaminated land. The EPA is required to notify council as soon as practicable when the declaration is no longer in force and the notation on the s10.7 certificate is no longer required.

Relationship to other regulatory instrument

This declaration does not affect the provisions of any relevant environmental planning instruments which apply to the land or provisions of any other environmental protection legislation administered by the EPA.

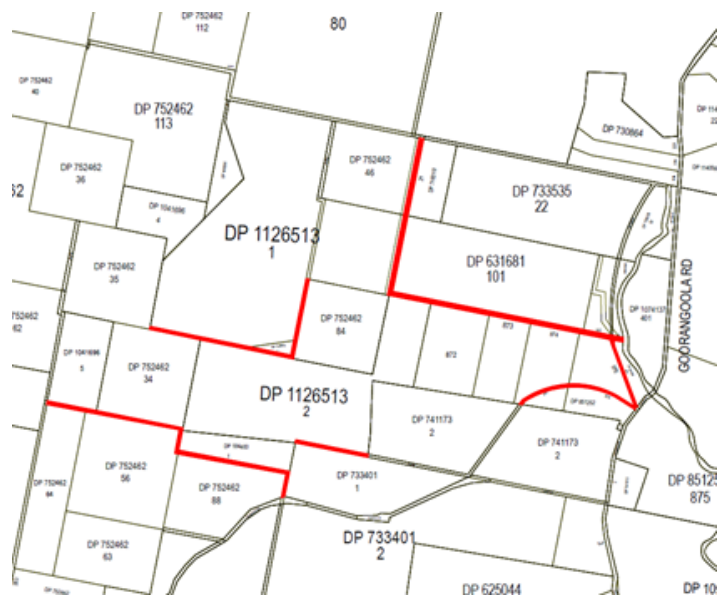

The object of the proposed Regulation is to support the operation of the *Gas and Electricity (Consumer Safety) Act 2017*. The proposed Regulation includes:

- the specifications and requirements for the sale of electrical articles and gas appliances, including disposal
- the standards for electrical installation, gasfitting and autogas work
- testing, inspection and compliance following electrical installation, gasfitting and autogas work
- maintenance of electrical and gas installations
- notifications of serious electrical and gas accidents and circumstances where interference with accident sites is permitted
- the forms, fees and penalty notice offences and penalty amounts for the purposes of the Act.

A Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Regulation. Copies of both the RIS and the proposed Regulation are available online at www.fairtrading.nsw.gov.au.

Details on how to make a submission are contained in the RIS.

Motor Dealers and Repairers Regulation 2014

I, Matthew Kean, Minister for Innovation and Better Regulation, in pursuance of clause 5A of the *Motor Dealers and Repairers Regulation 2014*, make the following Order.

Explanatory note

Under clause 5A of the *Motor Dealers and Repairers Regulation 2014*, the Minister for Innovation and Better Regulation may, by order published in the Gazette, declare that a specified event, held at a place where a number of motor dealers, motor vehicle manufacturers or other industry participants display motor vehicles, is an approved trade show.

The object of this Order is to declare the Outdoor Leisure Show to be held at the Lismore Showground, Alexandra Parade, Lismore (Lismore Show) to be an approved trade show for the period of 12 July to 15 July 2018 (inclusive). The effect of the Order is to exempt motor dealers whose ordinary place of business is outside NSW from the need to hold a NSW motor dealer's licence in order to offer or display a motor vehicle for sale at the Lismore Show. To receive the benefit of the exemption, eligible persons will need to satisfy the conditions of this Order and the Regulation.

The exemption will have effect only for the duration of the show and applies to participation in a trade show only to the extent that it involves advising persons with respect to the quality, performance and characteristics of motor vehicles and making offers to, or receiving offers from, persons to enter into agreements for the sale of motor vehicles (other than second-hand motor vehicles).

1 Name of Order

This Order is the *Motor Dealers and Repairers (Declaration of Approved Trade Show) Order 2018*.

2 Commencement

This Order commences on the day on which it is published in the NSW Government Gazette.

3 Definitions

In this Order:

Eligible person has the same meaning given to it in the Regulation 2014.

Lismore Show means the Outdoor Leisure Show held at the Lismore Showground, Alexandra Parade, Lismore.

Second-hand motor vehicles has the same meaning given to it in the Regulation.

The Act means the *Motor Dealers and Repairers Act 2013*.

The Regulation means the *Motor Dealers and Repairers Regulation 2014*.

4 Declaration of approved trade show

The Lismore Show is declared to be an approved trade show for the period beginning at 12:01am on 12 July 2018 and ending at 11:59pm on 15 July 2018.

5 Conditions

An eligible person must comply with the following conditions and the Regulation in order to receive the benefit of the exemption conferred by this Order:

- a) when making offers to, or receiving offers from, persons to enter into agreements for the sale of motor vehicles (other than second-hand motor vehicles) an eligible person must advise those persons in writing:
 - i. that the sale will be effected in the jurisdiction where the eligible person's ordinary place of business is;
 - ii. that the sale will not be subject to the dealer obligations or consumer protections provided under the Act or the Regulation;
 - iii. that the sale will be subject to the relevant dealer obligations, if any, or consumer protections that apply in the jurisdiction where the eligible person's ordinary place of business is;
 - iv. consumer protection under the Australian Consumer Law extends across all state and territory boundaries;
 - v. where the pick-up location would be for the vehicle if a sale is effected; and
 - vi. where the location would be for servicing and repair work for the vehicle if a sale is effected.

- b) display a sign at the stall or other place of business operated by the eligible person at the approved trade show that:
- i. uses language and a format, and is in a position, that makes the sign easy to read by any person approaching the stall or place, and
 - ii. includes the registered business name, or company name, address and inter-State or Territory licence name or number (if applicable) of the business ordinarily operated by the eligible person.

SWIMMING POOLS REGULATION 2018

Invitation to comment

Help us improve the laws that regulate swimming pools in NSW.

The NSW Government is remaking the *Swimming Pools Regulation 2008* as it is scheduled for automatic repeal on 1 September 2018 under the *Subordinate Legislation Act 1989*. The Government has released a proposed *Swimming Pools Regulation 2018* and a Regulatory Impact Statement about the proposed Regulation for public consultation.

The proposed Regulation contains many of the same provisions as the 2008 Regulation. It also makes some updates that include:

- enabling local authorities to charge fees for third and subsequent pool inspections, and increasing the maximum fees that local authorities may charge for exemption applications
- imposing a new obligation to display a warning notice while a swimming pool is being constructed, and making it an offence for failing to comply with that obligation
- changes to warning notices that are already required to be displayed under the Act
- improving public access to applicable Australian Standards, not just AS 1926.1 – 2007
- requiring certificates of non-compliance to be entered into the Swimming Pools Register
- greater flexibility for the way in which spa pools can be secured
- clarifying compliance with the Building Code of Australia performance requirements and other minor changes to improve the clarity and intent of the Regulation.
