WORKERS COMPENSATION (AMBULANCE SERVICES FEES) ORDER 2018

under the

Workers Compensation Act 1987

EXPLANATORY NOTE

Provision of Ambulance Services in New South Wales is restricted to the Ambulance Service of NSW and the entities listed under section 67E (3) of the *Health Services Act 1997*. This Order prescribes the rates applicable for Ambulance Services to an injured worker for which an employer is liable being the fees prescribed under section 67L of the *Health Services Act 1997* applicable from 7 September 2018.

1. Name of Order

This Order is the Workers Compensation (Ambulance Services Fees) Order 2018.

2. Commencement

This Order commences on 7 September 2018.

3. Application of Order

This Order applies to Ambulance Services provided on or after the date of commencement, whether it relates to an injury received before, on or after that date.

4. Fees for Ambulance Services

The fee amounts for which an employer is liable under the Act for provision of Ambulance Services to an injured worker are listed in Schedule A, being the fees prescribed under section 67L of the *Health Services Act 1997*.

5. Scope of Order (Additional Information)

- (a) The fees in Schedule A are payable only to:
 - The Ambulance Service of New South Wales;
 - The St John Ambulance Australia (NSW);
 - The Royal Flying Doctor Service of Australia (NSW Section);
 - The mines rescue company within the meaning of the *Coal Industry Act 2001* in the exercise of mines rescue functions;
 - A member of the New South Wales Mines Rescue Brigade established under the *Coal Industry Act* 2001; or,
 - Any person (or class of persons) prescribed by regulations made under the Health Services Act 1997.

6. Goods and Services Tax

No GST is payable on the fees in Schedule A.

7. Definitions

In this order:

Ambulance Services means the conveyance of an injured worker to or from a medical practitioner or hospital. This does not include conveyance of an injured worker from one public hospital to another.

Ambulance Service Provider is the Ambulance Service of NSW or the other entities listed in clause 5 above.

The *State Insurance Regulatory Authority* means the body corporate and NSW Government agency constituted under section 17 of the *State Insurance and Care Governance Act 2015*.

Emergency service means the provision of Ambulance Services by road ambulance, fixed wing aircraft or helicopter or a combination of these, from the scene of an accident, illness or injury to a public hospital or other destination.

GST means the goods and services tax payable under the GST Law.

GST Law has the same meaning as in the A New Tax System (Goods and Services Tax) Act 1999 (Cth).

Non-emergency service means an ambulance road service that is booked no later than 6pm on the day prior to service delivery with the service to commence and be completed between the hours of 8am and 6pm on the nominated service delivery date. An emergency service fee will be charged for any other service.

The Act means the Workers Compensation Act 1987.

Order granting exemption under section 284

Background

- a) Viva Energy Australia Pty Ltd has made an application for a temporary exemption from the provisions of the *Protection of the Environment (Clean Air) Regulation 2010* to install prescribed control equipment for petrol dispensers at:
 - i. Coles Express Blaxland 126 Great Western Highway
 - ii. Coles Express Carlingford West 286-288 Pennant Hills Road
 - iii. Coles Express Colyton 88-90 Great Western Highway
 - iv. Coles Express Lane Cove 250 Burns Bay Road
 - v. Coles Express Maroubra 959-961 Anzac Pde
- b) Viva Energy Australia Pty Ltd proposes to install prescribed control equipment for petrol dispensers at these sites by 28 February 2019 as part of its ongoing vapour recovery (Stage 2) upgrade works.

Order

By this Order the Environment Protection Authority ("EPA"), in the circumstances where:

- (i) the EPA is satisfied that it is not practicable to comply with the relevant provision or provisions, by implementing operational changes to plant or practices, and
- (ii) the EPA is satisfied that non-compliance with the provision or provisions will not have any significant adverse effect on public health, property or the environment, and
- (iii) the Board of the EPA approves the granting of the exemption

grants to Viva Energy Australia Pty Ltd [ABN 46 004 610 459] exemption from complying with the following provisions of the *Protection of the Environment (Clean Air) Regulation 2010* referred to in Table 1.

This exemption is granted under section 284 of the *Protection of the Environment Operations Act 1997* (the Act) subject to the following conditions:

- a. This exemption only applies to Viva Energy Australia Pty Ltd for the sites identified as (i) to (v) in the background of this Order.
- b. This exemption ceases at 11.59 pm on 28 February 2019.

This order takes effect from the date the order is published in the NSW Government Gazette unless otherwise varied or revoked. The Order may be varied or revoked under section 284 of the Act.



This Order is the Temporary Water Restriction (Macquarie and Cudgegong Regulated Rivers Water Sources) Order 2018.

2 Commencement

This Order commences the day on which it is published in the Gazette and will remain in force until 30 June 2019, unless it is repealed or modified by further order before that date.

3 Temporary water restrictions

The taking of water from the water source specified in Schedule 1 is restricted as specified in Schedule 2.

4 Interpretation

In this Order:

- (a) 30% of the volume of water in the carryover sub-account of the licence as at 1 July 2018, and
- (b) 30% of the volume of any water credited to a water allocation account of the licence after 1 July 2018 as a result of an assignment dealing with another Macquarie regulated river (general security) access licence.

Notes.

- (1) This Order does not impose any restriction on the take of water from Cudgegong regulated river (general security) access licences, which are regulated river (general security) access licences with extraction components that permit the taking of water upstream of Burrendong Dam water storage.
- (2) It is an offence, under section 336C of the *Water Management Act 2000*, to fail to comply with this direction. An individual found guilty of an offence under section 336C is liable to a penalty not exceeding 2,250 penalty units and, in the case of a continuing offence, a further penalty not exceeding 600 penalty units for each day the offence continues. A corporation found guilty of an offence under section 336C is liable to a penalty not exceeding 10,000 penalty units and, in the case of a continuing offence, a further penalty not exceeding 1,200 penalty units for each day the offence continues. As at the commencement of this Order, a penalty unit is \$110.
