





If the Owner of the Lot Burdened demonstrates, after providing the Authority Benefited with all information reasonably required by the Authority Benefited, that the removal and disposal of the redundant Rock Anchors from the Lot Burdened increases the cost of the proposed Redevelopment Works, the actual costs excluding any developer's margin, of the removal and disposal of the redundant Rock Anchors from the Lot Burdened, and any reasonable legal or reasonable non legal consultant's costs in advising on the removal and disposal of the redundant Rock Anchors from the Lot Burdened, reasonably incurred by the Owner of the Lot Burdened will be, subject to compliance with clause 1.3(m), recoverable from the Authority Benefited.
- (i) If the Authority Benefited fails to comply with clause 1.3(h) within the timeframe required under clause 1.3(h), the Owner of the Lot Burdened may do so and the reasonable costs reasonably incurred in doing so will be recoverable from the Authority Benefited.

- (j) After all Rock Anchors have been de-stressed the Authority Benefited must provide the Owner with a report detailing the location of anchor heads, inclination, direction and de-stressing information and confirming that all Rock Anchors have been satisfactorily de-stressed.
- (k) The Owner of the Lot Burdened may cut or remove any redundant or de-stressed Rock Anchors described in the Authority Benefited's notice referred to in paragraph (c) and otherwise deal with any part of such redundant or de-stressed Rock Anchors within the Easement Site as the Owner of the Lot Burdened sees fit. If the Owner of the Lot Burdened demonstrates, after providing the Authority Benefited with all information reasonably required by the Authority Benefited, that it cutting or removing and/or otherwise disposing of such redundant or de-stressed Rock Anchors increases the cost of the proposed Redevelopment Works, the actual cost excluding any developer's margin, of the cutting or removal and/or disposal of the redundant Rock Anchors from the Lot Burdened, and any reasonable legal or reasonable non legal consultant's costs in advising on cutting or removal and/or disposal of the redundant Rock Anchors from the Lot Burdened, reasonably incurred by the Owner of the Lot Burdened will be, subject to compliance with clause 1.3(m), recoverable from the Authority Benefited.
- (I) The earliest date on which the Authority Benefited is required to de-stress any Rock Anchors installed on the Easement Site by the Authority Benefited or its Authorised Users is 23 July 2022.
- (m) The Owner of the Lot Burdened must provide the Authority Benefited with detailed invoices setting out the scope of services undertaken that are recoverable from the Authority Benefited under this Easement and substantiating all amounts charged for such services.

1.4 Expiry of the Easement

- (a) This Easement will expire on the date on which the Authority Benefited gives the Owner of the Lot Burdened notice that it has de-stressed all stressed Rock Anchors installed on the Easement Site by the Authority Benefited or its Authorised Users and that all other Rock Anchors installed on the Easement Site are redundant and may be cut through by the Owner of the Lot Burdened as the Owner of the Lot Burdened sees fit.
- (b) If this Easement has expired under clause 1.4(a), the Owner of the Lot Burdened and the Authority Benefited (if requested by the Owner of the Lot Burdened) must take all reasonable steps to remove this Easement from the title of the Lot Burdened as soon as practicable, including preparing and executing all necessary documents and producing the relevant certificates of title at Land Registry Services NSW.
- (c) If this Easement has not expired by the date which is 100 years after the date of installation of the first Rock Anchor within the Easement Site by the Authority Benefited or its Authorised Users, the Authority Benefited must, subject to it being granted any required access rights over the Lot Burdened, promptly replace all Rock Anchors installed on the Easement Site by the Authority Benefited or its Authorised Users that have not been de-stressed or determined to be redundant as a result of the process set out in clause 1.3. In doing so, the Authority Benefitted must comply with the terms of the Easement, including without limitation, clause 1.2(b).

1.5 Incorporation of definitions and interpretation clauses

The provisions of clause 2 apply to this Easement to the extent relevant.

The name of the persons empowered to release, vary or modify this easement:

The Authority Benefited.

2. **GENERAL**

2.1 Exercise of the benefit of the Easement

The Authority Benefited may, in its discretion, permit any of its Authorised Users to exercise its rights and perform its obligations under any Easement from time to time.

2.2 Conditions

Each of the Conditions constitute and are covenants and agreements by and between the Authority Benefited and the Owner of the Lot Burdened for themselves and their respective successors, assigns and transferees with the intention and agreement that the benefit and burden of such covenants and agreements must pass with the benefit and burden of the Easement.

2.3 **Definitions**

Authorised Users means the agents, employees, contractors (and each of their subcontractors at any level) and consultants of the Authority Benefited and any other person authorised by the Authority Benefited to exercise the rights and perform the obligations of an Authorised User under this Easement.

Authority means any:

- (a) government, government department or government agency;
- (b) governmental, semi-governmental or judicial person; or
- (c) other person (whether autonomous or not) who is charged with the administration of a law.

Authority Benefited means Sydney Metro (ABN 12 354 063 515), a New South Wales Government agency constituted by section 3C of the *Transport Administration Act 1988* (NSW).

Building means the building and other structures (or any part of the building or other structures) on the Lot Burdened from time to time.

Conditions means the conditions contained in each Easement, excluding the section entitled "Easement summary" and including the general provisions set out in this clause 2.

Easement means each easement in this instrument and includes the Conditions in relation to that easement.

Easement Site means area marked as "V" shown on the plan at Annexure B.

Equipment means all necessary tools, implements, materials, machinery and vehicles.

Good Design and Construction Practice means practices followed when works are undertaken:

- (d) with due care and skill and applying professional standards in accordance with all laws, approvals, NSW Government policies, codes and guidelines in respect of building design, engineering and construction and demolition practices;
- (e) with due expedition and without unnecessary and unreasonable delays;
- in accordance with all laws; and

(g) using materials of merchantable quality which are fit for their intended purposes.

Lot Burdened means Lot 2 in Deposited Plan 1230458, being the whole of the land in Certificate of Title Folio Identifier 2/1230458.

Occupier means any person who is legally entitled and authorised to occupy any part of Lot Burdened from time to time.

Owner of the Lot Burdened means every person who is at any time entitled to an estate or interest in the Lot Burdened, including without limitation any freehold or leasehold estate or interest in possession in the Lot Burdened and each part of the Lot Burdened and any Owners Corporation in relation to the Lot Burdened.

Owners Corporation means an owners corporation constituted under the *Strata Schemes Management Act 2015* (NSW) or community association constituted under the *Community Land Development Act 1989* (NSW) and any similar body corporate serving the same functions and purposes as an owners corporation or a community association.

Permitted Purpose means installing Rock Anchors within the Easement Site and all works and activities associated with such installation, including maintenance, replacement, de-stressing and/or removal of the Rock Anchors.






