CONTAMINATED LAND MANAGEMENT ACT 1997

Environment Protection Authority

Declaration of significantly contaminated land

(Section 11 of the Contaminated Land Management Act 1997)

Declaration Number 20181115; Area Number 3439

The Environment Protection Authority (EPA) declares the following land to be significantly contaminated land under the *Contaminated Land Management Act 1997* ("the Act"):

1. Land to which this declaration applies ("the site")

This declaration applies to 19 Pine Road, Yennora, NSW identified as Lot 8 in DP 59412, in the local government area of Cumberland Council.

A map of the declared area is attached.

2. Nature of contamination affecting the site:

The EPA has found that the site is contaminated with the following substances ("the contaminants"):

• Chlorinated solvents, including trichloroethene (TCE), cis-1,2-dichloroethene (cis-DCE), 1,1-dichloroethene (DCA) and vinyl chloride.

3. Nature of harm that the contaminants has caused or may cause:

The EPA has considered the matters in s.12 of the Act and for the following reasons believes that the land is contaminated, and that the contamination is significant enough to warrant regulation under the Act:

- The groundwater and soil vapour beneath the site has been contaminated by chlorinated solvents.
- Concentrations of chlorinated solvents in groundwater exceed the ANZECC (2000) freshwater criteria on the site, and the contaminated groundwater has migrated off-site towards Prospect Creek.
- Concentrations of chlorinated solvents in soil vapour beneath the site have been measured at concentrations above the criteria protective of human health in industrial/commercial scenarios.
- Management of the contamination is required to prevent the migration of groundwater and vapour contamination from the site and to mitigate against potential risks to on-site and off-site receptors.

4. Further action under the Act

The making of this declaration does not prevent the carrying out of voluntary management of the site and any person may submit a voluntary management proposal for the site to the EPA.

5. Submissions invited

The public may make written submissions to the EPA on:

- Whether the EPA should issue a management order in relation to the site; or
- Any other matter concerning the site.

If management of the site or part of the site is required, the EPA may issue a management order under s.14 of the Act

Amendment/Repeal

This declaration may be amended or repealed. It remains in force until it is otherwise amended or repealed. The subsequent declaration must state the reasons for the amendment or repeal (s.44 of the Act).

Information recorded by the EPA

Section 58 of the Act requires the EPA to maintain a public record. A copy of this significantly contaminated land declaration will be included in the public record.

Information recorded by councils

Section 59 of the Act requires the EPA to give a copy of this declaration to the relevant local council. The council is then required to note on its planning certificate issued pursuant to s10.7 of the *Environmental Planning and Assessment Act 1979* that the land is declared significantly contaminated land. The EPA is required to notify council as soon as practicable when the declaration is no longer in force and the notation on the s10.7 certificate is no longer required.

Relationship to other regulatory instrument

This declaration does not affect the provisions of any relevant environmental planning instruments which apply to the land or provisions of any other environmental protection legislation administered by the EPA.

PROTECTION OF THE ENVIRONMENT OPERATIONS ACT 1997

Order granting exemption under section 284

Background

- a. 7-11 Stores Pty. Ltd. has made application for exemption from provisions of the *Protection of the Environment (Clean Air) Regulation 2010* to install prescribed control equipment for petrol dispensers at:
 - i. 2260 Pheasants Nest South Lot 12, South Western Freeway (Hume Hwy), Pheasants Nest, NSW 2574
 - ii. 2261 Pheasants Nest North Lot 13, South Western Freeway (Hume Hwy), Northbound, Pheasants Nest, NSW 2574
- b. Both sites are currently leased by 7-Eleven Stores Pty Ltd from NSW Roads and Maritime Services (RMS).
- c. RMS is conducting a tender process for the redevelopment and long-term lease at the two service station sites. 7-Eleven Stores is a tenderer for the long-term lease.
- d. Finalisation of the tender process is anticipated by August 2019.

- e. Until certainty of tenure is secured, 7-Eleven Stores Pty. Ltd. has been reluctant to proceed with installing vapour recovery stage 2 control equipment (VR2) at significant cost.
- f. 7-11 Stores Pty Ltd has committed to installing VR2 at both sites once occupation rights for both premises has been secured.
- g. 7-Eleven Stores Pty Ltd has a demonstrated commitment to meeting its VR requirements with 180 sites across Sydney, Central Coast, Newcastle and Wollongong Metropolitan areas already VR compliant.

Order

By this Order the Environment Protection Authority ("EPA"), in the circumstances where:

- 1. the EPA is satisfied that it is not practicable to comply with the relevant provision or provisions, by implementing operational changes to plant or practices, and
- 2. the EPA is satisfied that non-compliance with the provision or provisions will not have any significant adverse effect on public health, property or the environment, and
 - a. (iii) the Board of the EPA approves the granting of the exemption."

grants to 7-Eleven Stores Pty. Ltd. [ABN 48 005 299 427] exemption from complying with the following provisions of the Protection of the Environment (Clean Air) Regulation 2010 referred to in Table 1.

This exemption is granted under section 284 of the *Protection of the Environment Operations Act 1997* (the Act) subject to the following conditions:

- 1. This exemption only applies to 7-Eleven Stores Pty. Ltd. for the sites identified as (i) and (ii) in the background of this Order.
- 2. This exemption ceases at 11.59 pm on 30 June 2020 or 6 months following development approval granted from the local planning authority (whichever is sooner).

This order takes effect from the date the order is published in the NSW Government Gazette unless otherwise varied or revoked. The Order may be varied or revoked under section 284 of the Act.


