Temporary Water Restriction (Barwon-Darling Unregulated River Water Source) Amendment Order 2019

Explanatory note

This Order amends the temporary water restriction imposed by the *Temporary Water Restriction (Barwon-Darling Unregulated River Water Source) Order 2019* in pursuance of section 324 (1) of the *Water Management Act 2000* to extend the area of the restriction to apply to the Tilpa to Wilcannia Management Zone and Wilcannia to Upstream Lake Wetherell Management Zone and to extend the effect of the restriction until 30 August 2019 in order to protect environmental flows and water for essential needs. Section 43 (2) of the *Interpretation Act 1987* provides that the power to make an order under an Act includes the power to amend the order.
