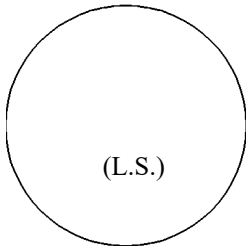

## Explanatory note

The object of this Proclamation is to declare that certain land that was vested in or belonged to The Aboriginal Lands Trust (before being vested in the New South Wales Aboriginal Land Council on the dissolution of that Trust) is vested in the Amaroo Local Aboriginal Land Council and the Purfleet/Taree Local Aboriginal Land Council.

## **Aboriginal Land Rights (Vesting) Proclamation 2019**

under the

Aboriginal Land Rights Act 1983

### **1 Name of Proclamation**

This Proclamation is the *Aboriginal Land Rights (Vesting) Proclamation 2019*.

### **2 Commencement**

This Proclamation commences on the day on which it is published in the Gazette.

### **3 Vesting of land in Local Aboriginal Land Councils**

The following land belonging to or vested in the New South Wales Aboriginal Land Council is vested as follows:

- (a) Lot 134, DP 756470 is vested in Amaroo Local Aboriginal Land Council,
- (b) Lot 251, DP 753149, Auto-Consol 6447–102, Auto-Consol 12976–220 and Lot B, DP 108481 are vested in Purfleet/Taree Local Aboriginal Land Council.
