## PROTECTION OF THE ENVIRONMENT OPERATIONS ACT 1997

Order granting exemption under section 284 of the Protection of the Environment Operations Act 1997

## **Background**

- a) The EPA has considered an exemption under s.284 of the *Protection of the Environment Operations Act 1997* (POEO Act) from the provision of s.88 of the POEO Act for scheduled waste facility operators in respect of Virgin Excavated Natural Material (VENM) and recovered fines used as landfill cover for bushfire generated waste originating from declared natural disaster areas disposed of at the facilities.
- b) The effect of the exemption is to exempt the scheduled waste facility operators listed below from the requirement to pay the waste levy in respect of VENM and recovered fines used as landfill cover for bushfire generated waste originating from declared natural disaster areas disposed of at the facilities.

#### Order

By this Order the Environment Protection Authority, in circumstances of an emergency, being the 2019/2020 bushfires in New South Wales, grants exemption from complying with s.88 of the POEO Act in respect of VENM and recovered fines used as landfill cover for bushfire generated waste originating from declared natural disaster areas, to the following:

## **Conditions**

This exemption is granted under s.284 of the POEO Act subject to the following conditions:

- 1. The scheduled waste facilities to which this Order applies must keep records of the amount of VENM and recovered fines in relation to which this exemption applies received at the facility and the dates the VENM and recovered fines is received at the facility as specified by the EPA
- 2. This exemption ceases to have effect on 30 November 2020.

## **Duration of Exemption**

This Order takes effect from the date the Order is published in the NSW Government Gazette unless otherwise varied or revoked. The Order may be varied or revoked under s.284 of the POEO Act.

## **Part 1 Preliminary**

#### 1 Name of Instrument

This Notification is the Marine Estate Management (Aquatic Reserve) Notification 2020.

#### 2 Commencement and duration

- (1) This Notification commences on the day on which it is published in the NSW Government Gazette.
- (2) This Notification will remain in force for 5 years after the date of publication.

## 3 Repeal

The Aquatic Reserve Notification 2015 dated 13 April 2015 published in NSW Government Gazette No. 32 on 17 April 2015 at pages 989 to 992 is repealed.

#### 4 Definitions

## (1) In this Notification:

Aboriginal cultural fishing has the same meaning as it has in section 4 of the Fisheries Management Act 1994.

Barrenjoey Head Aquatic Reserve, Boat Harbour Aquatic Reserve, Bronte-Coogee Aquatic Reserve, Cabbage Tree Bay Aquatic Reserve, Cape Banks Aquatic Reserve and Narrabeen Head Aquatic Reserve mean the aquatic reserves declared pursuant to section 194 of the Fisheries Management Act 1994, titled "Declaration of Aquatic Reserves" dated 31 March 2002 and published in Government Gazette No. 65 on 22 March 2002 at page 1731-1732, taken now to be Aquatic Reserves for the purposes of the Act.

**Bushrangers Bay Aquatic Reserve** means the aquatic reserve declared pursuant to section 194 of the *Fisheries Management Act 1994* and published in Government Gazette No. 65 of 14 May 1982 at page 2104, taken now to be an Aquatic Reserve for the purposes of the Act.

**Cook Island Aquatic Reserve** means the aquatic reserve declared pursuant to section 194 of the *Fisheries Management Act 1994* and published in Government Gazette No. 152 on 23 October 1998 at page 8435, taken now to be an Aquatic Reserve for the purposes of the Act.

finfish means bony fish (Osteichthyes) and cartilaginous fish (Chondrichthyes).

fishing gear has the same meaning as it has in section 4 of the Fisheries Management Act 1994.

*hand held line* means a rod and line or handline used in waters (other than inland waters) described in clause 43 of the *Fisheries Management (General) Regulation 2019*.

*lawful recreational net* means any net that may be used by a recreational fisher under the *Fisheries Management (General) Regulation 2019.* 

**Long Reef Aquatic Reserve** means the aquatic reserve declared pursuant to section 194 of the *Fisheries Management Act 1994* and published in *Government Gazette* No. 80 of 30 May 1980 at page 2787, taken now to be an Aquatic Reserve for the purposes of the Act.

*marine vegetation* has the same meaning as it has in section 4 the *Fisheries Management Act 1994*.

North Harbour Aquatic Reserve means the aquatic reserve declared pursuant to section 194 of the Fisheries Management Act 1994 and published in Government Gazette No. 46 of 26 March 1982 at page 1336, taken now to be an Aquatic Reserve for the purposes of the Act.

**spear gun** means a spear gun as defined in clause 52 of the *Fisheries Management (General)* Regulation 2019.

**Shiprock Aquatic Reserve** means the aquatic reserve declared pursuant to section 194 of the *Fisheries Management Act 1994* and published in Government Gazette No. 46 of 26 March 1982 at page 1336, taken now to be an Aquatic Reserve for the purposes of the Act.

the Act means the Marine Estate Management Act 2014.

the Management Rules Regulation means the Marine Estate Management (Management Rules) Regulation 1999.

the Principal Regulation means the Marine Estate Management Regulation 2017.

**Towra Point Aquatic Reserve** means the aquatic reserve declared pursuant to section 194 of the *Fisheries Management Act 199*4 and published in Government Gazette No. 49 of 12 April 1990 at page 3070, taken now to be an Aquatic Reserve for the purposes of the Act.

(2) Unless otherwise defined in this Instrument, words and expressions that are defined in the Act, Principal Regulation or Management Rules Regulation have the same meaning in this Instrument.

Note: aquaculture, fish, recreational fishing, take are defined in the Management Rules Regulation.


#### Part 2 Prohibition on activities

## 5 Prohibition on activities


- (1) A person is prohibited from carrying out the activities specified in Column 2 of Schedule 1 in the aquatic reserves specified opposite in Column 1 of Schedule 1, unless:
  - (a) the person has obtained the consent of the relevant Ministers or a permit issued by the relevant Ministers in accordance with the Principal Regulation, and
  - (b) the activity is for research purposes, aquaculture purposes, aquarium collecting purposes or Aboriginal cultural fishing purposes, or for any other purpose that is consistent with the objects of the Act and the purposes of aquatic reserves.

- (2) A person is prohibited from taking part in a recreational fishing competition at Barrenjoey Head Aquatic Reserve, Boat Harbour Aquatic Reserve, Bronte-Coogee Aquatic Reserve, Cabbage Tree Bay Aquatic Reserve, Cape Banks Aquatic Reserve and Narrabeen Head Aquatic Reserve unless the consent of the relevant Ministers or a permit issued by the relevant Ministers has been obtained for the recreational fishing competition in accordance with the Principal Regulation.
- (3) A person is prohibited from taking any fish or marine vegetation for research purposes at Barrenjoey Head Aquatic Reserve, Boat Harbour Aquatic Reserve, Bronte-Coogee Aquatic Reserve, Cabbage Tree Bay Aquatic Reserve, Cape Banks Aquatic Reserve and Narrabeen Head Aquatic Reserve unless the consent of the relevant Ministers or a permit issued by the relevant Ministers has been obtained for taking the fish or marine vegetation for research purposes in accordance with the Principal Regulation.
- (4) A person is prohibited from constructing, using or operating a jetty or slipway at the Shiprock Aquatic Reserve other than a jetty or slipway that was lawfully constructed and in existence immediately before 1 September 2002.


