# **CHARITABLE TRUSTS ACT 1993**

ORDER UNDER SECTION 12 CY PRES SCHEME RELATING TO THE ESTATE OF THE LATE JOHN WILLIAM NASH

Section 9(1) of the *Charitable Trusts Act 1993* permits the application of property cy pres where the spirit of the original trust can no longer be implemented.

Clause 4(a) of the Will of the late John William Nash ('the Will') provides that one half share of the residuary estate is to be held on trust for the 'Eurobodalla Cricket Association' and directs that the bequest is 'to be used for the purposes of junior and youth cricket, up to the age of eighteen years, in the Batemans Bay area.' The Will further provides that there be 'no restriction on the use' that the funds may be put 'including the provision of a scholarship for outstanding young cricketers (both male and female), provision of travel costs to competitions, special training events, provision of perpetual trophies for inter school competitions or local competitions.'

The bequest in clause 4(a) of the Will appears to create a charitable trust ('the trust'), as it is a gift for the physical education of persons of school age or just above. The value of the bequest is approximately \$275,000.

The Eurobodalla Cricket Association had its incorporation cancelled and no longer exists. There are no organisations bearing the name 'Eurobodalla Cricket Association' or similar. As such, a cy pres scheme has been sought to govern the distribution of the funds that are the subject of the trust.

The Batemans Bay Cricket Club ('BBCC') is an incorporated association whose genealogy involves the unification of a number of rival cricket clubs within Batemans Bay and surrounding areas. The testator was involved prominently with one of those cricket clubs. The dedicated purpose of the BBCC is cricket, to the furtherance of cricket in the Batemans Bay community. Relevantly, at the BBCC, junior cricket is played in the U10, U14 and U16 formats.

The BBCC proposes to apply the funds that are the subject of the trust to the benefit of junior and youth cricket within the Batemans Bay area, which may include establishing scholarships to provide financial assistance to junior cricketers in the Batemans Bay area of outstanding talent and/or insufficient means.

This is an appropriate matter in which the Attorney General should approve a cy pres scheme under section 12(1)(a) of the *Charitable Trusts Act* 1993.

The Solicitor General, under delegation from the Attorney General, has previously approved a recommendation that the Attorney General establish a cy pres scheme which would permit these charitable funds to be applied in a manner as close as possible to the original purposes of the Trust.

Pursuant to section 12 of the *Charitable Trusts Act 1993*, I hereby order that the bequest in clause 4(a) of the Will of the late Mr John William Nash to the Eurobodalla Cricket Association may be applied to the Batemans Bay Cricket Club for the above mentioned purposes.

The order will take effect 21 days after its publication in the Government Gazette, in accordance with section 16(2) of the *Charitable Trusts Act* 1993.

Authorisation to supply a form of the restricted substance metformin instead of the form prescribed that is a medicine in short supply (short supply medicine)

#### 1 Authorisation

This order authorises a pharmacist to supply the corresponding listed form of metformin on the prescription of an authorised practitioner where the form of metformin prescribed is in short supply (Short Supply Medicine), as notified by the Therapeutic Goods Administration's Serious Shortage Medicine Substitution Notice, Reference Number SSN 20-01:

Daily dose of metformin modified release 500mg tablets	Medicine to be supplied
1500 mg (3 tablets) daily	One metformin modified release 1000 mg tablet plus one metformin immediate release 500 mg tablet daily in separate doses
1000 mg (2 tablets) daily	One metformin modified release 1000 mg tablet daily
500 mg (1 tablet) daily	One metformin immediate release 500 mg tablet daily

# 2 Conditions

- a. The Short Supply Medicine remains on a current notice that is published by the Therapeutic Goods Administration as a medicine that is in short supply and that may be substituted for the other form of the Short Supply Medicine.
- b. The patient must present with a valid prescription for the medicine to be substituted for.
- c. It is not practicable for the patient to obtain a prescription for the substitute form/s of the medicine from a prescriber before the patient needs the supply of the prescribed medicine
- d. The patient or his/her agent or carer must consent to receiving the medicine/s supplied pursuant to the notice.
- e. The pharmacist must be satisfied that in his/her professional judgement, after taking all reasonable steps to obtain all relevant information including discussing the matter with the prescriber if possible, that the patient is suitable to receive the different form of the medicine under the notice, considering factors such as known previous hypersensitivity or severe adverse reaction to excipients.
- f. The pharmacist must make a reasonable attempt to inform the prescriber of the change to the prescribed medicine, if possible before supplying the medicine.
- g. The total quantity of active drug supplied and the total number of days' treatment supplied must be the same as those specified (explicitly or implicitly) in the prescription.
- h. The pharmacist must label the medicine/s with directions for the same daily dosage of active drug (totalled where two forms are supplied) that was specified in the prescription.
- i. The pharmacist must record full details of the supply in the pharmacy's dispensing record system, including the medicine form prescribed and the medicine form/s which was/were supplied in its place.
- j. The pharmacist must annotate the prescription with details of the form/s of the medicine supplied.
- k. The medicine form/s supplied must be currently registered on the Australian Register of Therapeutic Goods and as supplied by the licensed manufacturer/sponsor. However in order to comply with condition (g), the pharmacist may break or combine ARTG pack/s to make a quantity of tablets of the medicine which differs from the pack size/s specified in the Register.

### 3 Duration

This authority commences on the day it is signed and dated, and expires on the date that the prescribed medicine ceases to be on a current Serious Shortage Medicine Substitution Notice that is published by the Therapeutic Goods Administration as a medicine that is in short supply and that may be substituted for the other form of the Short Supply Medicine; or otherwise on a date that this authority is revoked.
