**MENTAL HEALTH ACT 2007**  
**Section 109**  
**Declaration of mental health facility**

I, **DAVID PEARCE, Executive Director, Mental Health Branch**, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and to, in part, facilitate the transfer of patients from a current declared mental health facility situated at Level 2 of the O'Brien Centre, off Burton Street, Darlinghurst to alternate accommodation at Level 3 Aikenhead Building off Victoria Street Darlinghurst, **DO HEREBY:**

(a) **REVOKE** the Order published in the NSW Government Gazette No. 77 of 10 August 2018, declaring certain premises of St Vincent's Hospital, Darlinghurst, to be a declared mental health facility for the purposes of section 109 of the Mental Health Act 2007; and

(b) **DECLARE** the following premises to be a declared mental health facility for the purposes of section 109 the *Mental Health Act 2007*:

**St Vincent's Hospital Campus, 390 Victoria Street, Darlinghurst NSW 2010, comprising the following units:**

- **St Vincent's Hospital Sydney Psychiatric Emergency Care Centre (PECC) Unit**, at:
  - Level 2 of the O'Brien Centre, off Burton Street, Darlinghurst until vacated or 30 June 2020, whichever occurs first, and
  - Level 3 (Ground Floor), Aikenhead Building, off Victoria Street, Darlinghurst.
- **St Vincent's Hospital Sydney Psychiatric and Non-Prescribed Drug Assessment (PANDA) Unit**, Level 3 (Ground Floor), Aikenhead Building, off Victoria Street.
- **The Caritas Centre**, located on Level 5 of the O'Brien Centre, off Burton Street; and

(c) **DECLARE** this facility to be designated as a “**mental health assessment and inpatient treatment**” facility.
