REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Lake Albert, Wagga Wagga – all navigable waters

**Duration**

- 8:00am to 6:00pm – Saturday 1 May 2021
- 8:00am to 6:00pm – Sunday 2 May 2021

**Detail**

Water Ski Races will be conducted on the navigable waters of Lake Albert, involving the use of high speed power vessels which will be active in the area at the location and times specified above.

Support vessels will be present to manage the event. Participating vessels and skiers will operate at high speed, presenting a significant potential hazard to other waterway users.

An **EXCLUSION ZONE** is specified during the event and will comprise the entirety of Lake Albert, which will effectively close the Lake to all other vessel use between the above times for this event.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone, which will be monitored by event safety official vessels and Maritime officers.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)

REGULATION OF VESSELS – EXCLUSION ZONE

**Location**

Wagonga Inlet – navigable waters within a 125 metre radius from a barge positioned approximately midway between Shell Point and Lavender Point and 300 metres north-west from the landmark of Quota Park on Riverside Drive, near the township of Narooma.

**Duration**

- 7:30pm to 9:30pm – Friday 30 April 2021

**Detail**

A fireworks display will be conducted over the navigable waters of Wagonga Inlet. The display will be staged from a stationary barge which will be anchored in the waterway at the centre of the location and during the time specified above.

An **EXCLUSION ZONE** is specified during the event, which will be indicated by the presence of control vessels stationed around the perimeter of the zone.

Unauthorised vessels and persons are strictly prohibited from entering the exclusion zone which will be patrolled by both control vessels and official NSW Maritime vessels.

Penalties may apply (section 12(5) - *Marine Safety Act 1998*)
