Order under clause 5 of Schedule 2 to the *Environmental Planning and Assessment (Savings, Transitional and Other Provisions) Regulation 2017*

This Order takes effect upon publication in the *New South Wales Government Gazette*.

NATIONAL PARKS AND WILDLIFE ACT 1974

Draft Plan of Management for Royal National Park, Heathcote National Park and Garawarra State Conservation Area

The Royal National Park, Heathcote National Park and Garawarra State Conservation Area draft Plan of Management is on public exhibition. Key issues addressed in the draft plan include:

- the continued protection and management of natural and cultural values
- managing increasing visitor numbers and improving the visitor experience, including upgrades to visitor facilities and a zoning system to guide future management of the parks
- a draft Mountain Biking Plan that proposes a network of tracks in the parks and provides strategies for ensuring environmental protection and maintaining rider and visitor safety.
