Explanatory note

The object of this Order is to extend the requirements for persons to wear fitted face coverings in certain circumstances to Greater Sydney, including the local government areas of the City of Shellharbour and the City of Wollongong and omit the provision that repeals certain subclauses on 24 June 2021 in relation to the requirement to wear fitted face coverings.

[1] Clause 5 Direction of Minister to wear fitted face coverings

Omit "a relevant local government area" wherever occurring from clause 5(1) and 5(1E). Insert instead "Greater Sydney".

[2] Clause 5(1CA)

Insert after subclause (1C)-

(1CA) Subclause (1)(d)(i) does not apply to a hospitality venue or a kiosk.

[3] Clause 5(6), definition of "relevant local government area"

Omit the definition.

[4] Clause 5(7)

Omit the subclause.
