ONE MILLION (\$1,000,000) REWARD

On the 4 July 1975, Juanita Nielsen, aged 38 years, was last seen at the Carousel Cabaret, Kings Cross, NSW. Juanita has not been seen since and it is believed that she was kidnapped and murdered. Her body has never been located.

Notice is hereby given that a reward of up to one million dollars (\$1,000,000) will be paid by the Government of New South Wales for information leading to the arrest and conviction of the person or persons responsible for the murder of Juanita Nielsen or for information leading to the location and recovery of the remains of Juanita Nielsen.
