It is hereby notified, for general information, that Her Excellency the Governor, has, in the name and on behalf of Her Majesty, this day assented to the under mentioned Acts passed by the Legislative Assembly and Legislative Council of New South Wales in Parliament assembled, viz.:

Act No. 13 — An Act to provide for mandatory blood testing of a person in circumstances where the person's bodily fluid comes into contact with a health, emergency or public sector worker as a result of the person's deliberate action and the worker may be at risk of contracting a blood-borne disease. **[Mandatory Disease Testing Bill]**

Act No. 15 — An Act to amend the Prevention of Cruelty to Animals Act 1979 to increase penalties for certain animal welfare offences; and for other purposes. **[Prevention of Cruelty to Animals Amendment Bill]**
