#### **Explanatory note**

The object of this Order is to amend the Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021—

- (a) to allow overnight travellers and persons working in the local area to be accommodated in caravan parks and camping grounds in Greater Sydney while the Order remains in force, and
- (b) to make other minor amendments in the nature of law revision.

#### Schedule 1 Amendment of Public Health (COVID-19 Temporary Movement and Gathering Restrictions) Order 2021

#### [1] Clause 23 Direction of Minister concerning gatherings of more than 10 persons

Insert "in Greater Sydney" after "outdoor public gathering" in clause 23(1).

#### [2] Clause 23(3)(c)

Omit the paragraph.

#### [3] Clause 24 Directions of Minister concerning closure of certain premises

Insert "in Greater Sydney" after "members of the public" wherever occurring in clause 24(1) and (2).

#### [4] Clause 24(1)(a)(iii), (b)(iv), (c)(i), (f)(ii) and (g)(i)

Omit the subparagraphs.

#### [5] Clause 24(1)(l)(i)

Insert ", overnight travellers, persons working in the local area" after "camping ground" in clause 24(1)(1)(i).

#### [6] Clause 24(3)

Insert "in Greater Sydney" after "following".

#### [7] Schedule 1 Reasonable excuses

Insert "or, if the person is not residing or staying in Greater Sydney, in the local government area in which the person is residing or staying" after "Greater Sydney" in item 5.

#### [8] Schedule 1, item 7

Omit the item. Insert instead-

7 A funeral or memorial service, or a gathering following a funeral or memorial service, at which there are no more than 100 persons, including the person conducting the service.
