# Public Health (COVID-19 Gathering Restrictions) Order (No 2) Amendment Order (No 2) 2021

under the

Public Health Act 2010

## Explanatory note

The objects of this Order are to—

- (a) clarify the requirements for the occupiers of premises in relation to the registration, and provision to the Chief Health Officer, of the contact details of persons entering the premises when those persons are unable to register their contact details electronically with Service NSW, and
- (b) require persons entering an early education and care facility, other than children being cared for at the facility, to register their contact details electronically with Service NSW, and
- (c) clarify that the requirement for a person to register their contact details electronically with Service NSW when entering premises does not apply in relation to farms.

This Order is made under section 7 of the *Public Health Act 2010*.

### **1 Name of Order**

This Order is the *Public Health (COVID-19 Gathering Restrictions) Order (No 2) Amendment Order (No 2) 2021*.

### **2 Commencement**

This Order commences on the commencement of the *Public Health (COVID-19 Gathering Restrictions) Order (No 2) Amendment Order 2021*.

## **Schedule 1 Amendment of Public Health (COVID-19 Gathering Restrictions) Order (No 2) 2021**

- [1] **Clause 8 Directions about number of persons allowed on residential premises**  
Omit “25(4) and (5)” from clause 8(4). Insert instead “25(2)”.
- [2] **Clause 25 Directions about persons providing contact details**  
Omit “with Service NSW” from clause 25(2).
- [3] **Clause 25(2)(a)**  
Insert “with Service NSW” after “details”.
- [4] **Clause 25(2)(b)**  
Insert “with Service NSW” after “details”, wherever occurring.
- [5] **Clause 25(3)**  
Omit the subclause. Insert instead—  
(3) The occupier of the premises must take reasonable steps to ensure a person complies with this clause when entering the premises.
- [6] **Clause 26 Direction about record keeping by occupiers concerning contact details**  
Omit clause 26(1). Insert instead—  
(1) This clause applies to the occupier of premises if a person’s contact details are provided to the occupier under clause 25(2) rather than Service NSW.
- [7] **Clause 26(2)(a)**  
Omit the paragraph. Insert instead—  
(a) to keep, for at least 4 weeks, a record of the contact details in a way that ensures the record is readily accessible and in an appropriate form to provide to the Chief Health Officer under paragraph (b), and
- [8] **Clause 26(2)(b)**  
Insert “, in electronic form,” after “the record”.
- [9] **Schedule 3 Premises requiring electronic entry records**  
Insert after Schedule 3, Part 1, item 6—  
**6A** Early education and care facilities, but not a child entering a facility for the purposes of being cared for at the facility
- [10] **Schedule 3**  
Insert after Schedule 3, Part 3, item 42(b)—  
(c) farms
