# Retirement Villages (COVID-19 Asset Management Plans) Order 2021

under the

#### Retirement Villages Act 1999

I, the Hon Kevin Anderson MP, Minister for Better Regulation and Innovation, under section 204 of the *Retirement Villages Act 1999*, make the following Order.

I am satisfied that the exemptions are necessary because the provisions from which the exemptions are granted require non-compliance with a Public Health Order issued under section 7 of the *Public Health Act 2010* that relates to COVID-19.

#### **Explanatory note**

Under section 204 of the *Retirement Villages Act 1999* (the Act), the Minister for Better Regulation and Innovation, may by order published in the Gazette, exempt retirement villages, residents and operators of retirement villages, from provisions of or under, the Act that require non-compliance with an order under section 7 of the *Public Health Act 2010* (Public Health Act) relating to COVID-19.

The objects of this Order are -

- (1) to exempt the operator from the requirement to obtain, and provide to residents, a written opinion of the auditor or an independent qualified quantity surveyor as to whether the asset management plan contains the matters specified in clauses 26D and 26F of the Regulation, and
- (2) to exempt the operator from preparing an asset management plan under clause 26C of the Regulation.

These exemptions will have effect for the duration of the prescribed period.

# Retirement Villages (COVID-19 Asset Management Plans) Order 2021

under the

Retirement Villages Act 1999

### Part 1 Preliminary

#### 1. Name of Order

This Order is the Retirement Villages (COVID-19 Asset Management Plans) Order 2021.

#### 2. Commencement

This Order commences on the day on which it is published in the NSW Government Gazette and remains in force for the prescribed period.

#### 3. Definitions

In this Order -

**3-year report** means a report included in the proposed annual budget relating to capital maintenance for major items of capital, including shared major items of capital, for a relevant 3-year period that is extracted from the information contained in the asset management plan current for that period.

asset management plan means an asset management plan under the Act, section 101A.

**auditor** means the auditor whose appointment as the auditor of a retirement village has received the consent, or is taken to have received the consent, of the residents of the retirement village under the Act, Part 7, Division 6, Subdivision 1.

**independent assessment** means a written opinion of the auditor or an independent qualified quantity surveyor as to whether the asset management plan contains the matters specified in clauses 26D and 26F of the Regulation

operator of a retirement village has the same meaning given to it in the Act

**public health order** includes any Public Health Order issued under the *Public Health Act 2010* related to COVID-19.

prescribed period means the period -

- (a) starting on the commencement of this Order, and
- (b) ending on 31 March 2022.

**proposed annual budget** means a proposed annual budget referred to in section 112 of the Act.

**resident** of a retirement village has the same meaning given to it in the Act.

the Act means the Retirement Villages Act 1999.

the Regulation means the Retirement Villages Regulation 2017.

#### 4. Relationship with Orders under the Public Health Act 2010

To the extent that this Order is inconsistent with a Public Health Order issued under Part 2 of the *Public Health Act*, the Public Health Order prevails.

# Part 2 Exemptions

#### Preparation of asset management plans

- (1) The Minister exempts the operator of a retirement village from the requirement to prepare an asset management plan and to have an independent assessment of an asset management plan under clause 26C(1) of the Regulation subject to the conditions of subclause (2).
- (2) The operator of a retirement village must:
  - a. present the parts of an asset management plan necessary to meet the requirements of clause 19A of the Regulation relating to the maintenance of major items of capital in the 3-year report, and
  - b. ensure that the first asset management plan produced by the operator under clause 26C (either during the prescribed period or after the prescribed period) is subject to independent assessment.
