The NSW Government invites public comment on a proposed Fair Trading Amendment (Commercial Agents) Regulation 2021. The proposed Regulation supports the *Fair Trading Amendment (Commercial Agents) Act 2016*. It details the reasons a person may be disqualified from carrying out commercial agent activities or deemed not fit and proper to hold a commercial agents licence and the rules of conduct for commercial agents.
