Declaration of mental health facility

I, DAVID PEARCE, Executive Director, Mental Health Branch, acting under delegation from the Secretary, NSW Ministry of Health, and pursuant to section 109 of the *Mental Health Act 2007*, and section 43 of the *Interpretation Act 1987*, DO HEREBY

- (a) REVOKE the Order published in the NSW Government Gazette number 114 of the 6 October 2017, declaring the Bega Valley Mental Health Service to be a declared mental health facility for the purposes of section 109 of the Mental Health Act 2007; and
- (b) DECLARE the **Bega Valley Community Mental Health Service** situated at the South East Regional Hospital, Virginia Drive, Bega NSW 2550, to be a declared mental health facility under the *Mental Health Act 2007*; and
