Explanatory note

The object of this Order is to amend the Public Health (COVID-19 General) Order 2021—

- (a) to allow up to 1,000 persons to attend COVID-19 safe outdoor gatherings for community sporting activities in the general area, and
- (b) to provide for the repeal on 1 November 2021 of the direction for an occupier of a hospitality venue in the general area not to permit a group booking of more than 20 persons unless it is for a significant event authorised to be held at the venue.

This Order is the Public Health (COVID-19 General) Amendment Order (No 3) 2021.

2 Amendment of Public Health (COVID-19 General) Order 2021

(1) Clause 2.10 Hospitality venues—no large bookings

Insert at the end of the clause—

- (2) This clause is repealed at the beginning of 1 November 2021.
- (2) Clause 2.12 Maximum number of persons—certain outdoor events

Omit clause 2.12(1)(b). Insert instead—

- (b) for a COVID-19 safe outdoor public gathering other than for a community sporting activity—200 persons,
- (b1) for a COVID-19 safe outdoor public gathering for a community sporting activity—1,000 persons,
- (3) Schedule 4 COVID-19 Safety Plans

Insert "other than for community sporting activities" after "gathering" in item 11, column 2.

(4) Schedule 4, item 11A

Insert after item 11—

11A COVID-19 safe outdoor public gatherings for community sporting activities

Community sport

(5) Schedule 6 Dictionary

Insert in alphabetical order—

community sporting activity includes a training session for a community sporting activity.
